### ACTIVE MOBILITY ACT 2017

#### ACTIVE MOBILITY (SHARED PATHS) (AMENDMENT NO. 2) ORDER 2023

In exercise of the powers conferred by section 6 of the Active Mobility Act 2017, the Land Transport Authority of Singapore makes the following Order:

#### **Citation and commencement**

1. This Order is the Active Mobility (Shared Paths) (Amendment No. 2) Order 2023 and comes into operation on 19 May 2023.

#### **Amendment of First Schedule**

2.—(1) In the Active Mobility (Shared Paths) Order 2018 (G.N. No. S 260/2018) (called in this Order the principal Order), in the First Schedule, in Part 1, after item 34, insert —

“35. A path (approximately 0.23 kilometre in length) starting at the junction of Ang Mo Kio Street 22 and Ang Mo Kio Street 23, running along Ang Mo Kio Street 23 and ending at the junction of Ang Mo Kio Street 23 and Ang Mo Kio Avenue 3.

36. A path (approximately 0.21 kilometre in length) starting at the junction of Ang Mo Kio Street 43 and Ang Mo Kio Avenue 10, running along Ang Mo Kio Avenue 10 and ending at the junction of Ang Mo Kio Avenue 10 and Ang Mo Kio Avenue 3.

37. A path (approximately 0.14 kilometre in length) starting at the junction of Ang Mo Kio Avenue 10 and Ang Mo Kio Avenue 3, running along Ang Mo Kio Avenue 3 and ending at the junction of Ang Mo Kio Avenue 3 and Ang Mo Kio Street 43.”

(2) In the principal Order, in the First Schedule, in Part 2 —

(a) replace item 17 with —

“17. A path (approximately 0.39 kilometre in length) starting at Chai Chee Road, running along New Upper Changi Road

and ending before the intersection of New Upper Changi Road, Bedok North Avenue 1 and Bedok South Road near lamp post 41.”;

(b) replace item 26 with —

“26. A path (approximately 0.38 kilometre in length) starting at Bedok North Street 1, running along Bedok North Avenue 3 and ending at Bedok North Road.”; and

(c) replace item 48 with —

“48. A path (approximately 0.62 kilometre in length) starting at Block 152B Bedok South Road, running along Bedok South Road and ending at Bedok South Avenue 3.”.

(3) In the principal Order, in the First Schedule, in Part 7, replace item 2 with —

“2. A path (approximately 0.45 kilometre in length) starting at the intersection of Sims Drive, Geylang East Central and Aljunied Road, running along Aljunied Road and ending at the Pelton Canal.”.

(4) In the principal Order, in the First Schedule, in Part 13, after item 30, insert —

“31. A path (approximately 0.44 kilometre in length) starting at the junction of Pasir Ris Drive 8 and Pasir Ris Grove, running along Pasir Ris Grove and ending at the junction of Pasir Ris Grove and Pasir Ris Drive 1.”.

(5) In the principal Order, in the First Schedule, in Part 17, after item 26, insert —

“27. A path (approximately 0.63 kilometre in length) starting near Block 107C Canberra Street, running along the canal and ending near Block 115D Canberra Link.

28. A path (approximately 0.30 kilometre in length) starting at the junction of Canberra Street and Canberra Walk, running along Canberra Walk and ending at the junction of Canberra Walk and Canberra Crescent.

29. A path (approximately 0.15 kilometre in length) starting at the junction of Canberra Crescent and Canberra Walk, running along Canberra Walk and ending at the junction of Canberra Walk and Canberra Link.

30. A path (approximately 0.15 kilometre in length) starting at the junction of Canberra Walk and Canberra Link, running along Canberra Link and ending at the junction of Canberra Link and Canberra Way.

31. A path (approximately 0.53 kilometre in length) starting at the junction of Canberra Link, Sembawang Way and Canberra Road, running along Canberra Road and ending at the junction of Canberra Road, Sembawang Avenue and Sembawang Road.”.

(6) In the principal Order, in the First Schedule, in Part 18, after item 15, insert —

- “16. A path (approximately 0.22 kilometre in length) starting at the junction of Sengkang East Avenue and Compassvale Road, running along Compassvale Road and ending at the junction of Compassvale Road and Compassvale Drive.
17. A path (approximately 0.16 kilometre in length) starting at the junction of Compassvale Drive and Compassvale Road, running along Compassvale Road and ending at the junction of Compassvale Road, Sengkang Square and Compassvale Walk.
18. A path (approximately 0.19 kilometre in length) starting at the junction of Sengkang Square, Compassvale Walk and Compassvale Road, running along Compassvale Road and ending at the junction of Compassvale Road and Sengkang East Way.
19. A path (approximately 0.30 kilometre in length) starting at the junction of Sengkang East Way and Compassvale Road, running along Compassvale Road and ending at the junction of Compassvale Road, Compassvale Crescent and Compassvale Street.”.

(7) In the principal Order, in the First Schedule, in Part 20, after item 47, insert —

- “48. A path (approximately 0.16 kilometre in length) starting at the junction of Tampines Avenue 6 and Tampines Avenue 11, running along Tampines Avenue 11 and ending at the junction of Tampines Avenue 11 and Tampines North Drive 1.
49. A path (approximately 0.17 kilometre in length) starting at the junction of Tampines North Drive 1 and Tampines Avenue 11, running along Tampines Avenue 11 and ending at the junction of Tampines Avenue 11 and Tampines North Drive 4.
50. A path (approximately 0.15 kilometre in length) starting at the junction of Tampines North Drive 4 and Tampines Avenue 11, running along Tampines Avenue 11 and ending at the junction of Tampines Avenue 11 and Tampines Avenue 10.
51. A path (approximately 0.15 kilometre in length) starting at Tampines Street 61 near lamp post 11, running along Tampines Street 61 and ending at the junction of Tampines Street 61 and Tampines Avenue 6.

52. A path (approximately 0.30 kilometre in length) starting at the junction of Tampines Avenue 6 and Tampines Street 61, running along Tampines Street 61 and ending at the junction of Tampines Street 61 and Tampines North Drive 1.
  53. A path (approximately 0.34 kilometre in length) starting at the junction of Tampines Avenue 11 and Tampines North Drive 1, running along Tampines North Drive 1 and ending at the junction of Tampines North Drive 1 and Tampines Street 61.
  54. A path (approximately 0.23 kilometre in length) starting at the junction of Tampines Street 61 and Tampines North Drive 1, running along Tampines North Drive 1 and ending at the junction of Tampines North Drive 1 and Tampines Avenue 9.
  55. A path (approximately 0.20 kilometre in length) starting at the junction of Tampines Avenue 11 and Tampines Avenue 6, running along Tampines Avenue 6 and ending at the junction of Tampines Avenue 6 and Tampines Street 62.
  56. A path (approximately 0.28 kilometre in length) starting at the junction of Tampines Street 62 and Tampines Avenue 6, running along Tampines Avenue 6 and ending at the junction of Tampines Avenue 6 and Tampines Street 61.
  57. A path (approximately 0.24 kilometre in length) starting at the junction of Tampines Street 61 and Tampines Avenue 6, running along Tampines Avenue 6 and ending at the junction of Tampines Avenue 6 and Tampines Avenue 9.
  58. A path (approximately 0.60 kilometre in length) starting at the junction of Tampines Avenue 12 and Tampines North Drive 2, running along Tampines North Drive 2 and ending at the junction of Tampines North Drive 2 and Tampines Street 62.
  59. A path (approximately 0.70 kilometre in length) starting at the junction of Tampines North Drive 2 and Tampines Street 62 near lamp post 103S1, running along Tampines Street 62 and ending at the junction of Tampines Street 62 and Tampines North Drive 2.
  60. A path (approximately 0.29 kilometre in length) starting at the junction of Tampines North Drive 2 and Tampines Street 62, running along Tampines Street 62 and ending at the junction of Tampines Street 62 and Tampines Avenue 6.”.

(8) In the principal Order, in the First Schedule, in Part 22 —

(a) replace item 16 with —

“16. A path (approximately 0.73 kilometre in length) starting at the junction of Yishun Ring Road and Yishun Avenue 4, running along Yishun Avenue 4 and ending at the junction of Yishun Avenue 4 and Yishun Central.”;

(b) replace item 38 with —

“38. A path (approximately 0.45 kilometre in length) starting at lamp post 56 along Yishun Avenue 6, running along Yishun Avenue 6 and ending at the junction of Yishun Avenue 6 and Yishun Street 42.”;

(c) replace item 40 with —

“40. A path (approximately 0.36 kilometre in length) starting at the junction of Yishun Avenue 4 and Yishun Ring Road, running along Yishun Ring Road and ending at the junction of Yishun Ring Road and Yishun Avenue 2 (excluding the path between lamp post 107 and lamp post 97 along Yishun Ring Road).”; and

(d) after item 45, insert —

“46. A path (approximately 0.12 kilometre in length) starting at the junction of Yishun Ring Road and Yishun Avenue 4, running along Yishun Avenue 4 and ending at the junction of Yishun Avenue 4 and Yishun Street 51.

47. A path (approximately 0.36 kilometre in length) starting at the junction of Yishun Avenue 4 and Yishun Street 51, running along Yishun Avenue 4 and ending at the junction of Yishun Avenue 4 and Yishun Avenue 1.

48. A path (approximately 0.31 kilometre in length) starting at the junction of Yishun Avenue 6 and Yishun Street 31, running along Yishun Street 31 and ending at the junction of Yishun Street 31 and Yishun Ring Road.”.

(9) In the principal Order, in the First Schedule, in Part 23, after item 7, insert —

“8. A path (approximately 0.06 kilometre in length) starting at the junction of South Woodlands Drive and Woodlands Avenue 5, running along Woodlands Avenue 5 and ending at the junction of Woodlands Avenue 5 and Woodlands Avenue 2.”.

(10) In the principal Order, in the First Schedule, in Part 24 —

(a) replace items 9 and 10 with —

- “9. A path (approximately 0.22 kilometre in length) starting at the junction of Senja Close and Senja Road, running along Senja Road and ending at the junction of Senja Road and Senja Link.
  10. A path (approximately 0.17 kilometre in length) starting at the junction of Bukit Panjang Road and Bukit Panjang Ring Road near lamp post 13, running along Bukit Panjang Ring Road and ending at the junction of Bukit Panjang Ring Road and Senja Road.”; and

(b) after item 15, insert —

- “16. A path (approximately 0.12 kilometre in length) starting at the junction of Senja Link and Senja Road, running along Senja Road and ending at the traffic crossing near lamp post 74S1.
17. A path (approximately 0.05 kilometre in length) starting at the traffic crossing near lamp post 74S1, running along Senja Road and ending at the traffic crossing near lamp post S18.
18. A path (approximately 0.13 kilometre in length) starting at the traffic crossing near lamp post S18, running along Senja Road and ending at the junction of Senja Road and Bukit Panjang Ring Road.
19. A path (approximately 0.13 kilometre in length) starting at the junction of Senja Road and Senja Link, running along Senja Link and ending at the junction of Senja Link and Bukit Panjang Ring Road.
20. A path (approximately 0.19 kilometre in length) starting at the junction of Senja Link and Bukit Panjang Ring Road, running along Bukit Panjang Ring Road and ending at the junction of Bukit Panjang Ring Road and Senja Road (excluding the path in front of Jelapang LRT station).
21. A path (approximately 0.43 kilometre in length) starting at the junction of Senja Road and Bukit Panjang Ring Road near Block 601, running along Bukit Panjang Ring Road and ending at the junction of Bukit Panjang Ring Road, Senja Link and Jelapang Road.”.

### **Amendment of Third Schedule**

**3.** In the principal Order, in the Third Schedule, after item 132, insert —

“133. Tampines Avenue 9 Park Connector (approximately 1.40 kilometres in length) starting at the junction of Tampines Avenue 10 and Tampines Avenue 9, running along Tampines Avenue 9 and ending at Tampines Eco Green Park.

134. A path (approximately 0.20 kilometre in length) starting at Riverbank at Fernvale Condominium, running along the west bank of Sungei Punggol and ending at Sengkang Riverside Park.”.
