In exercise of the powers conferred by sections 14(1) and 19(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

#### **Citation and commencement**

1. This Order is the Infrastructure Protection (Protected Places) (No. 9) Order 2020 and comes into operation on 17 April 2020.

#### **Premises declared to be protected place**

2. The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected place.

#### **Revocation**

3. The Protected Places (No. 2) Order 2005 (G.N. No. S 432/2005) is revoked.

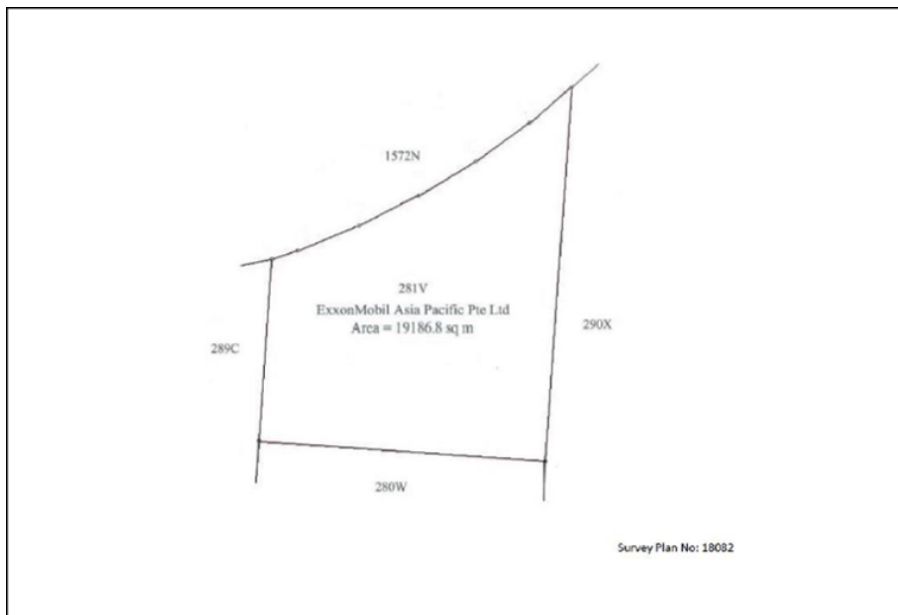
