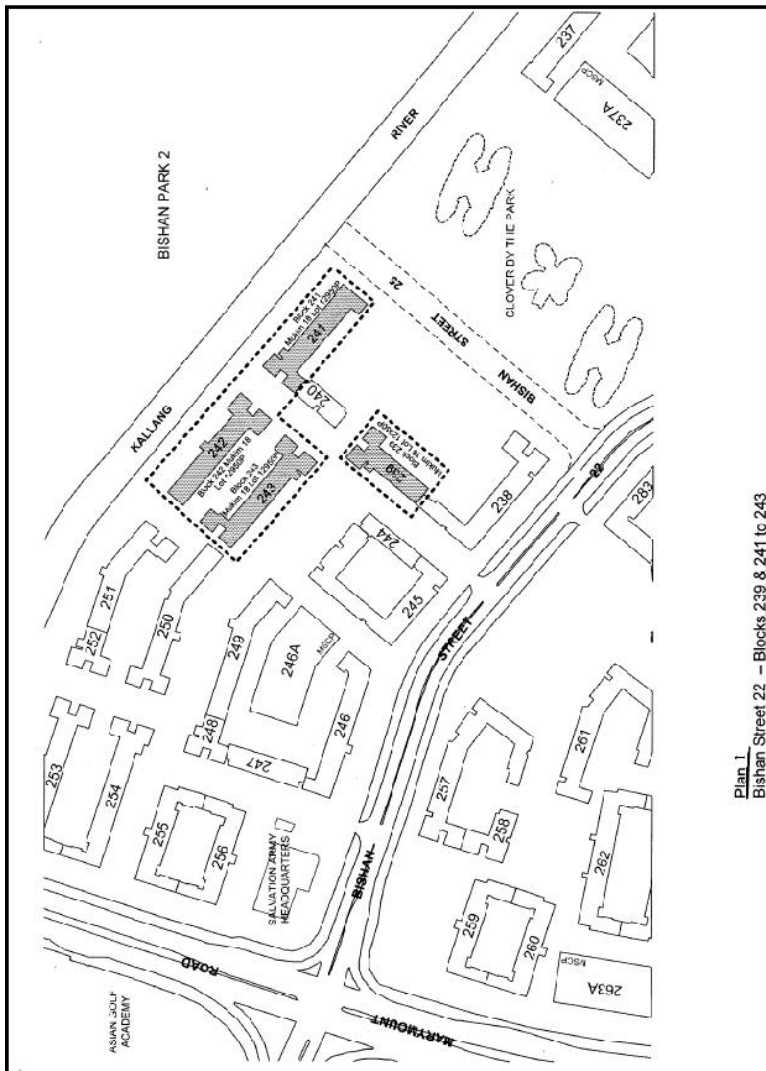
Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

1. All that part of the housing estate of the Board at Bishan Street 22 comprised in Lot number 12950P in Mukim 18 and on which Apartment Blocks 239, 241, 242 and 243 are erected, and which is more particularly delineated in Plan 1.

BISHAN STREET 22



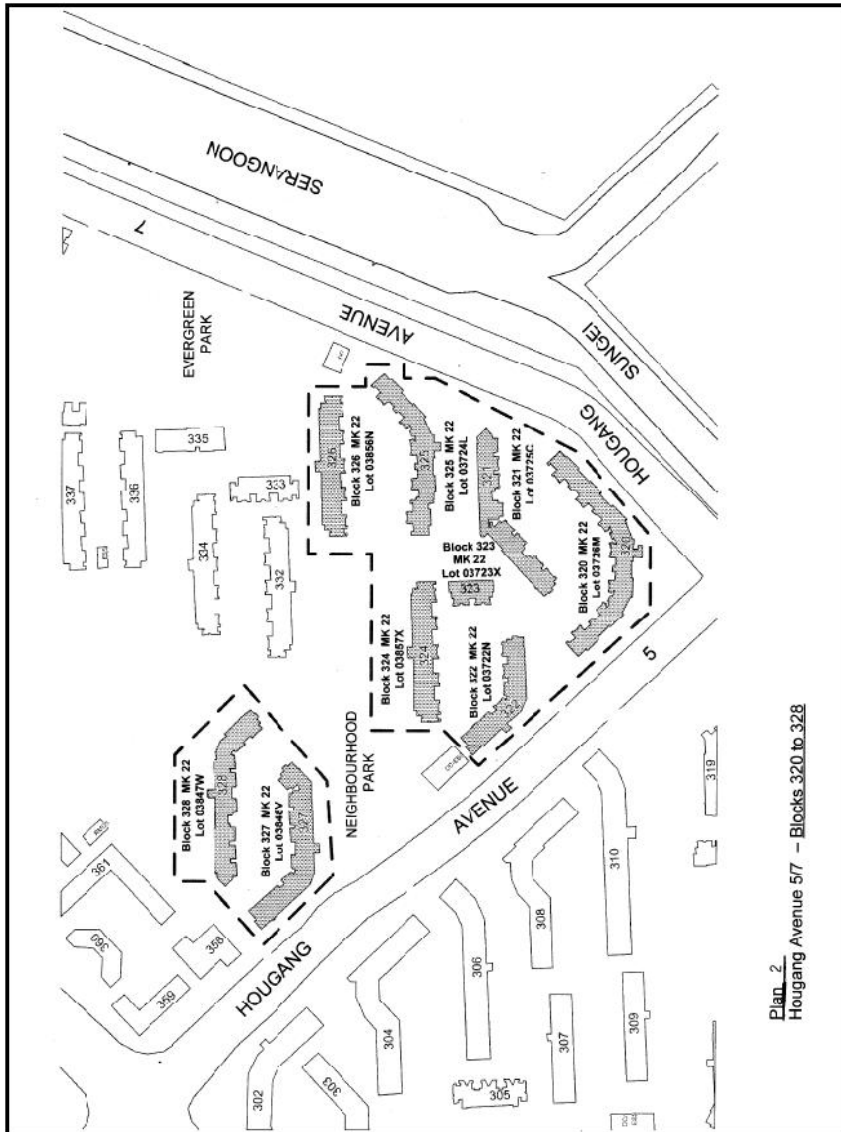
Plan 1

HOUGANG AVENUE 5/7



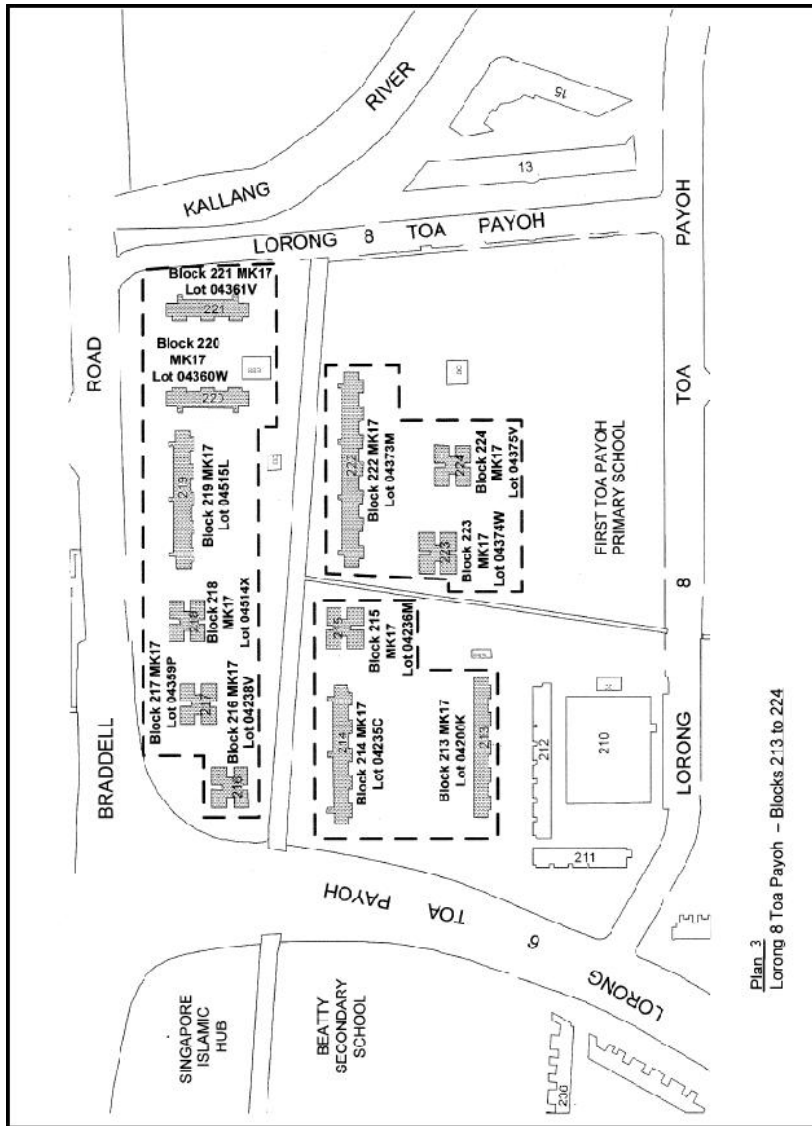
Plan 2

LORONG 8 TOA PAYOH



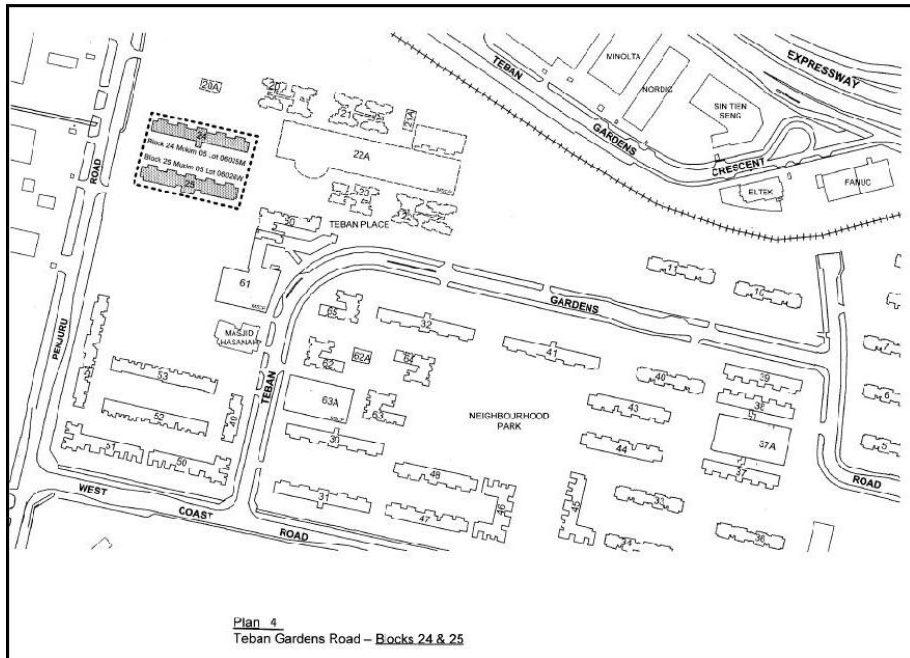
Plan 3
