In exercise of the powers conferred by section 65B(1) of the Housing and Development Act the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 11) Order 2012 and shall come into operation on 4th July 2012.

#### **Declaration of precincts for lift upgrading works**

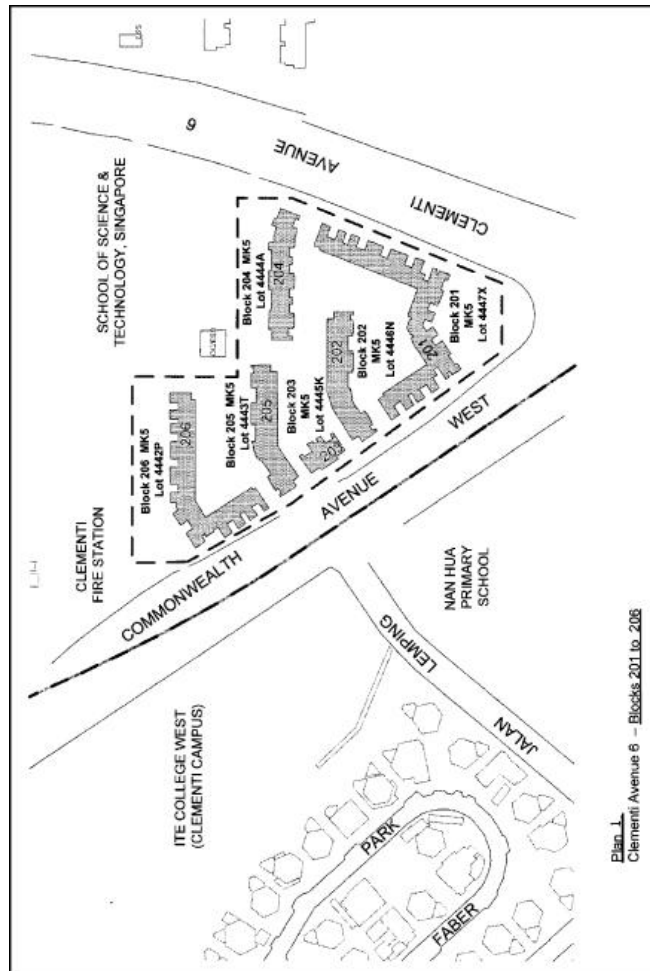
2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

## THE SCHEDULE

1. All that part of the housing estate of the Board at Clementi Avenue 6 comprised in Lot numbers 4447X, 4446N, 4445K, 4444A, 4443T and 4442P in Mukim 5 and on which Apartment Blocks 201, 202, 203, 204, 205 and 206 are erected, and which is more particularly delineated in Plan 1.

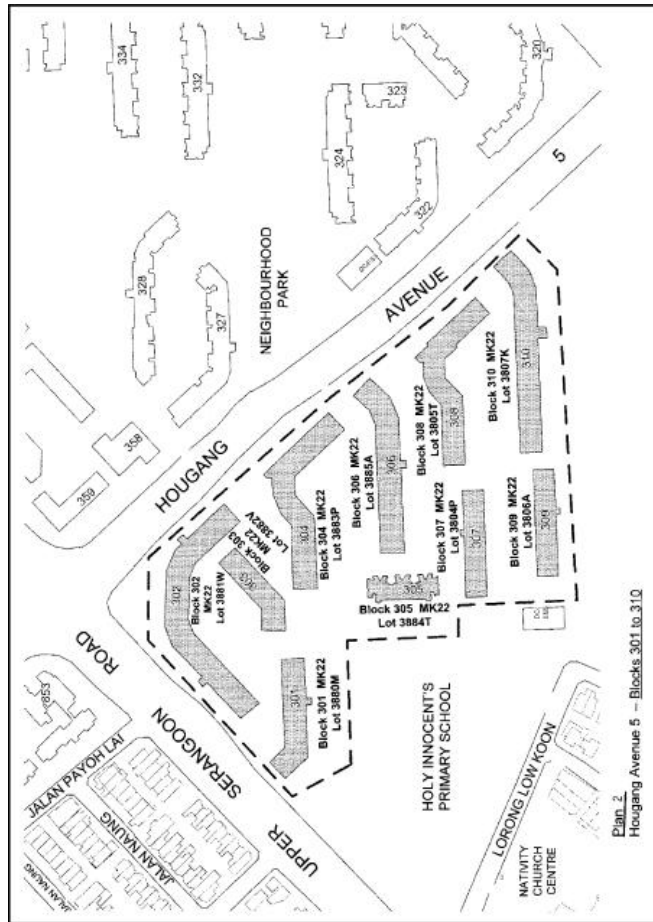
## CLEMENTI AVENUE 6

All that part of the housing estate of the Board at Hougang Avenue 5 comprised in Lot numbers 3880M, 3881W, 3882V, 3883P, 3884T, 3885A, 3804P, 3805T, 3806A and 3807K in Mukim 22 and on which Apartment Blocks 301, 302, 303, 304, 305, 306, 307, 308, 309 and 310 are erected, and which is more particularly delineated in Plan 2.

HOUGANG AVENUE 5

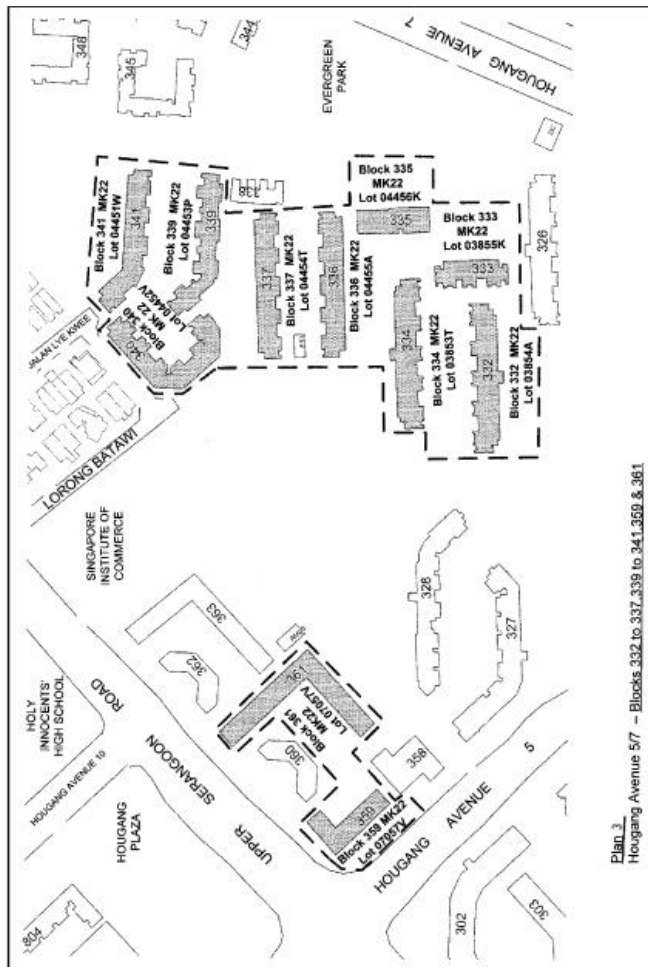

HOUANG AVENUE 5/7



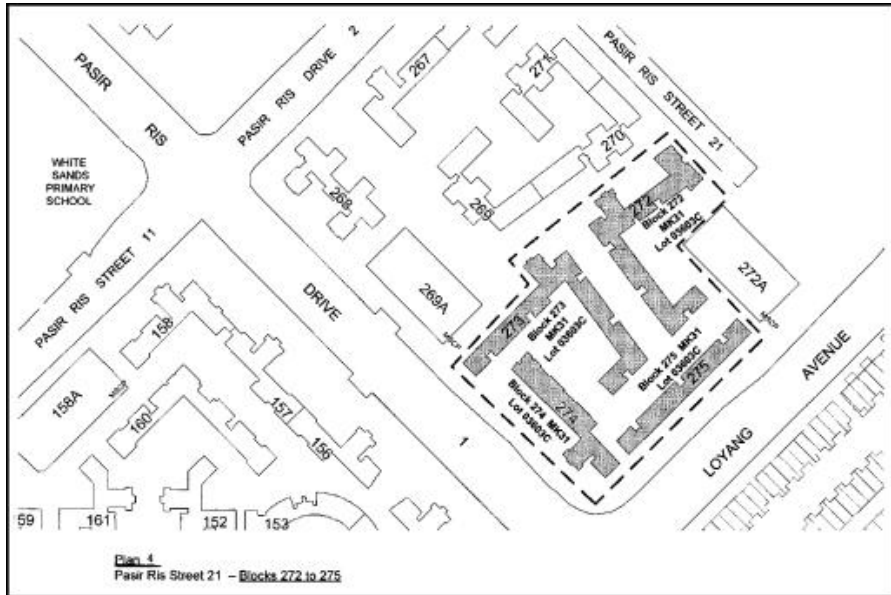
Plan 3
