PEOPLE'S ASSOCIATION ACT
(CHAPTER 227)

PEOPLE'S ASSOCIATION
(COMMUNITY DEVELOPMENT COUNCILS)
(AMENDMENT) RULES 2011

In exercise of the powers conferred by section 9(a) and (b) of the People's Association Act, the Board of Management of the People's Association hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the People's Association (Community Development Councils) (Amendment) Rules 2011 and shall be deemed to have come into operation on 27th May 2011.

Amendment of First Schedule

2. The First Schedule to the People's Association (Community Development Councils) Rules (R 2) is amended —

- (a) by deleting the words "Hong Kah" in the first column of item 1 and substituting the words "Hong Kah North, Pioneer, Yuhua";
- (b) by deleting the words ", Nee Soon Central and Nee Soon East" in the first column of item 2 and substituting the words "and Nee Soon";
- (c) by deleting the words "Yio Chu Kang, Bishan-Toa Payoh, Jalan Besar" in the first column of item 3 and substituting the words "Bishan-Toa Payoh, Moulmein-Kallang, Radin Mas, Sengkang West, Whampoa";
- (d) by inserting, immediately after the word "Tampines" in the first column of item 4, the words ", Punggol East"; and
- (e) by deleting the word "MacPherson" in the first column of item 5 and substituting the word "Mountbatten".

Savings and transitional provisions

3.—(1) As from 27th May 2011 —

- (a) all decisions of the Council for any District existing immediately before that date (referred to in this paragraph as a former District) that affect or relate to any part thereof which, by virtue of these Rules, becomes comprised in or part of another District shall, as from 27th May 2011, be deemed to be the decisions of the Council of that other District; and
- (b) all funds held on that date by or on behalf of the Council for any former District for the purpose of any part thereof which, by virtue of these Rules, becomes comprised in or part of another District shall, as from 27th May 2011, be deemed to be the funds of the Council of that other District.

(2) If any question arises as to whether any particular funds of a Council have been transferred under paragraph (1)(b) to another Council, a certificate under the hand of the Chief Executive Director of the People's Association shall be conclusive evidence that the funds were or were not so transferred.
