COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 24) NOTIFICATION 2012

ARRANGEMENT OF PARAGRAPHS

2. Exemption The Schedule

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 24) Notification 2012.

Exemption

2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of the "Dream Draw" promotion to be held from 12th July 2012 to 9th August 2012 (both dates inclusive) and comprising the following draws to be held as part of the promotion at the Casino Royale Bar at Resorts World at Sentosa:

- (a) the "Daily Draws" to be held daily from 12th July 2012 to 7th August 2012 (both dates inclusive) at 9.30 p.m.; and
- (b) the "Dream Draw Finale" lucky draw to be held on 9th August 2012 at 11 p.m.

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- 1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. Every draw shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
- 3. Every draw shall be conducted in public.
- 4. Every draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
- 5. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. Every draw shall not involve the use of any instrument or appliance of gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. Resorts World at Sentosa Pte. Ltd. shall, before the start of any of the draws, undertake to ensure that
 - (a) all winners are notified by phone; and
 - (b) an audited statement of accounts shall, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 10th November 2012.
