ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 27) Notification 2013.

Exemption

2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of the “Scratch and Win” promotion to be held every Tuesday, Wednesday and Thursday between 18th June 2013 and 29th August 2013 (both dates inclusive) (referred to in this sub-paragraph as the relevant days) and comprising the following lotteries to be held at Resorts World at Sentosa:

- (a) the “Instant Win” to be held, as part of the “Scratch and Win” promotion, during the relevant days at the Casino’s main gaming area; and

(b) the “Lucky Draw” to be held, as part of the “Scratch and Win” promotion, at 3 p.m. and 9 p.m. during the relevant days at the Casino Royale Bar.

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2(2)

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a lottery, the time, date and place of the lottery shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
2. Every lottery shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
3. Every lottery shall be conducted in public.
4. Every lottery by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
5. Every lottery shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
6. Every lottery shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
7. Resorts World at Sentosa Pte. Ltd. shall, before the start of any of the lotteries, undertake to ensure that —
 - (a) the results of the lotteries are displayed at the prize board located at the main entrance of the casino operated by Resorts World at Sentosa Pte. Ltd. after each lottery is completed; and
 - (b) an audited statement of accounts shall, together with the results of the lotteries, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 30th November 2013.
