In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

**Citation and commencement**

**1.** This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 7) Order 2011 and shall come into operation on 1st July 2011.

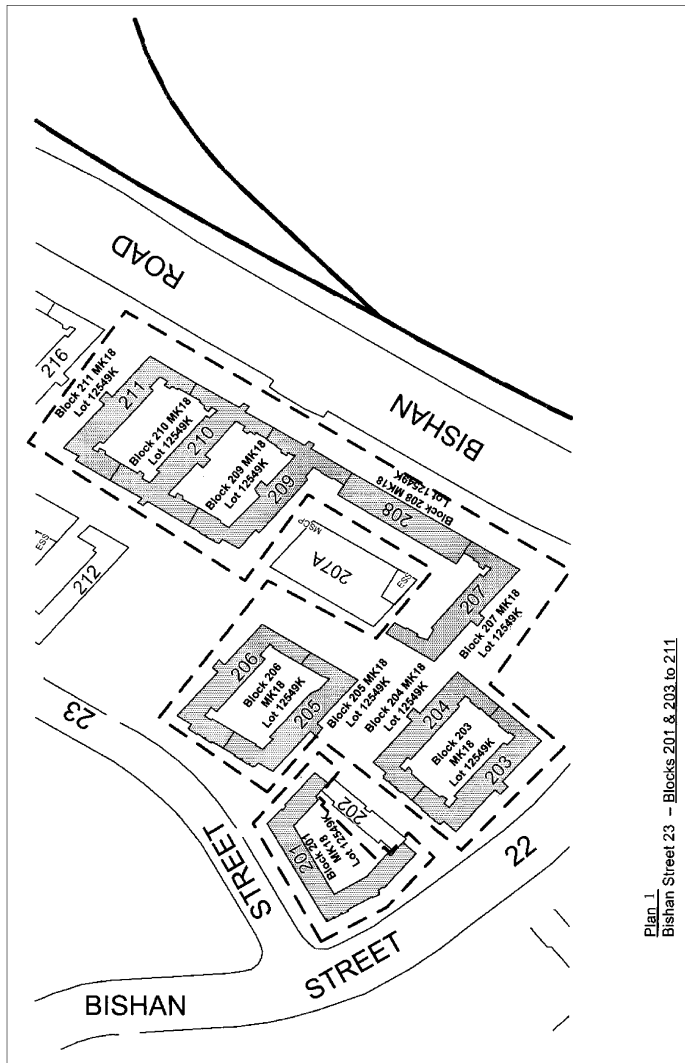
**Declaration of precincts for lift upgrading works**

**2.** The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

1. All that part of the housing estate of the Board at Bishan Street 23 comprised in Lot number 12549K in Mukim 18 and on which Apartment Blocks 201, 203, 204, 205, 206, 207, 208, 209, 210 and 211 are erected, and which is more particularly delineated in Plan 1.

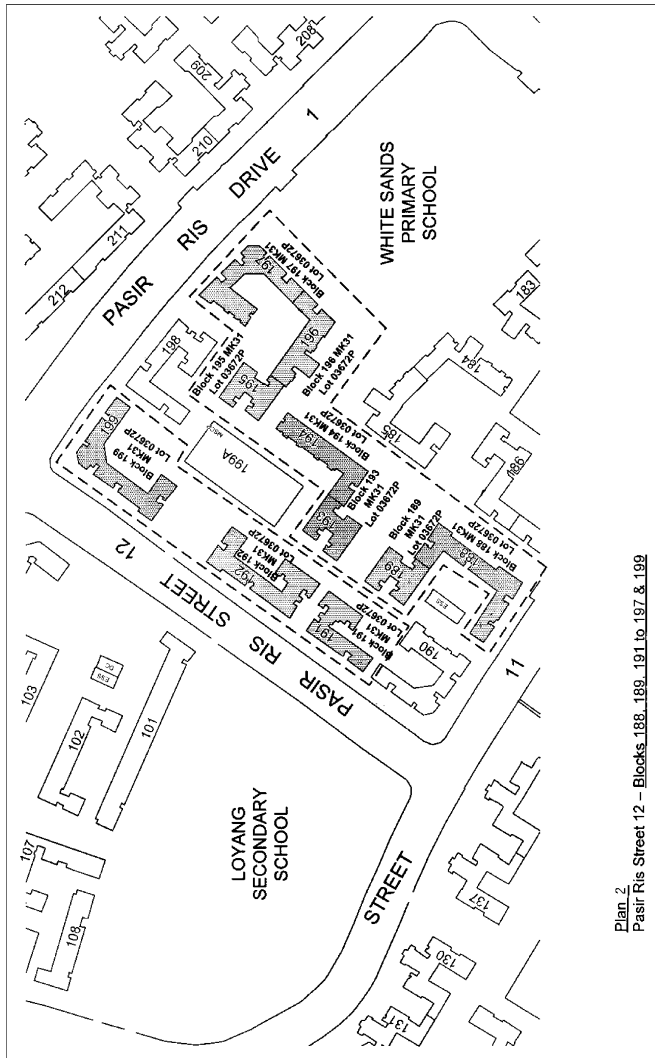
PLAN 1

PASIR RIS STREET 12



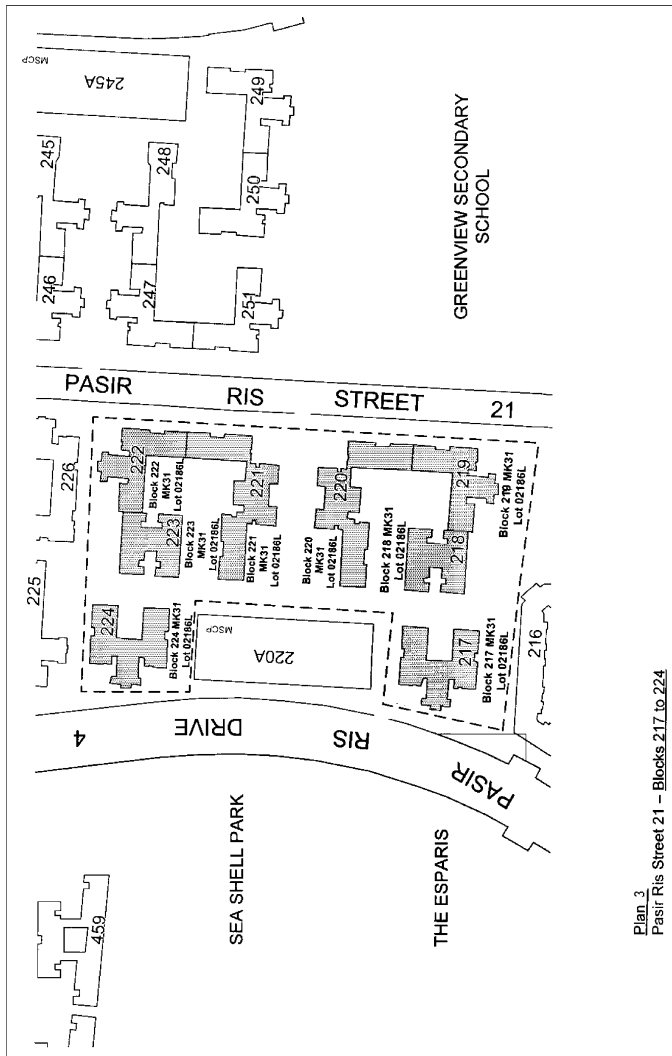
Plan 2

Pasir Ris Street 21 – Blocks 217 to 224

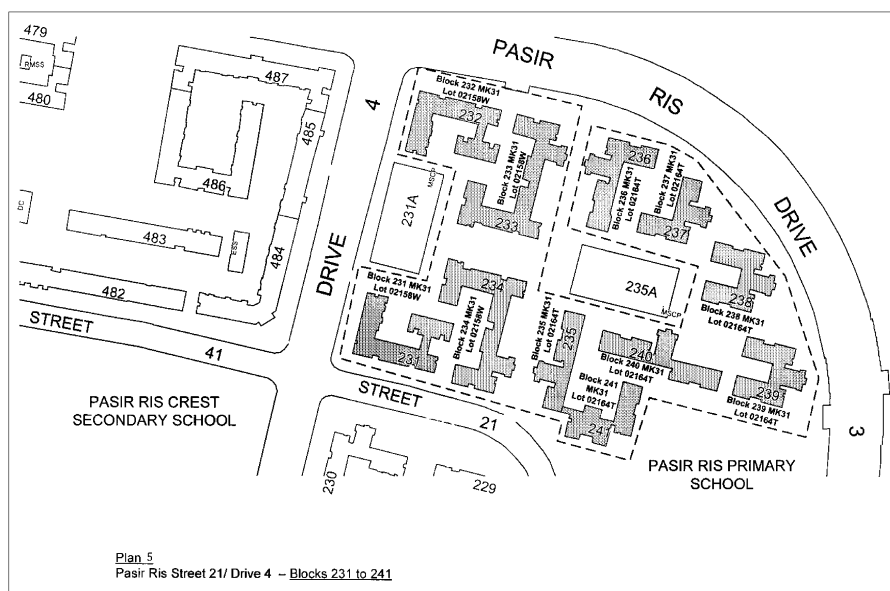
