ENVIRONMENTAL PUBLIC HEALTH ACT (CHAPTER 95)

ENVIRONMENTAL PUBLIC HEALTH (PUBLIC CLEANSING) (AMENDMENT NO. 2) REGULATIONS 2018

In exercise of the powers conferred by section 111 of the Environmental Public Health Act, the National Environment Agency, with the approval of the Minister for the Environment and Water Resources, makes the following Regulations:

Citation and commencement

1.—(1) These Regulations are the Environmental Public Health (Public Cleansing) (Amendment No. 2) Regulations 2018 and, except for regulations 2(c), (d) and (f) and 4, come into operation on 1 July 2018.

(2) Regulation 2(f) comes into operation on 1 September 2018.

(3) Regulations 2(c) and (d) and 4 come into operation on 1 November 2018.

Amendment of Second Schedule

2. The Second Schedule to the Environmental Public Health (Public Cleansing) Regulations (Rg 3) (called in these Regulations the principal Regulations) is amended —

- (*a*) by deleting the words "Veolia ES Singapore Pte. Ltd." in paragraph 1 and substituting the words "800 Super Waste Management Pte Ltd";
- (*b*) by deleting sub-paragraphs (2) and (3) of paragraph 1 and substituting the following sub-paragraphs:

4. The Fourth Schedule to the principal Regulations is amended by deleting the words "SEMBWASTE PTE. LTD." in the Schedule heading and substituting the words "800 SUPER WASTE MANAGEMENT PTE LTD".
