COMMON GAMING HOUSES (EXEMPTION) (NO. 43) NOTIFICATION 2014

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 43) Notification 2014.

Exemption

- **2.**—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of
 - (a) "The Magical Genie Draw" promotion to be held from 11th June 2014 to 3rd August 2014 (both dates inclusive); and
 - (b) the following draws to be held at the Main Casino Floor (B2M) at Marina Bay Sands as part of "The Magical Genie Draw" promotion:
 - (i) 5 sessions hourly from 8 p.m. to 12 midnight on 4th July 2014 and 5th July 2014, respectively;

- (ii) 5 sessions hourly from 6 p.m. to 10 p.m. on 6th July 2014;
- (iii) 5 sessions hourly from 8 p.m. to 12 midnight on 18th July 2014 and 19th July 2014, respectively;
- (iv) 5 sessions hourly from 6 p.m. to 10 p.m. on 20th July 2014;
- (v) 5 sessions hourly from 8 p.m. to 12 midnight on 1st August 2014 and 2nd August 2014, respectively;
- (vi) 5 sessions hourly from 6 p.m. to 10 p.m. on 3rd August 2014.
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
- 2. Every draw shall be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
- 3. Every draw shall be conducted in public.
- 4. Every draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
- 5. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
- 6. Every draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
- 7. The results of the draws must be announced via the AV system at the draw area, in addition to being displayed on the casino's plasma television sets, after each draw is completed.

THE SCHEDULE — continued

8. Marina Bay Sands Pte. Ltd. shall, before the start of the draws, undertake to ensure that an audited statement of accounts, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 4th November 2014.
