In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 5) Order 2016 and comes into operation on 29 August 2016.

**Declaration of precincts for Home Improvement Programme**

2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.



## THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Bedok North Road and Bedok Reservoir Road, comprised in Lot numbers 02107V, 02108P, 02109T, 02207C, 02110V, 02111P, 02112T and 02113A in Mukim 28 and on which Apartment Blocks 701, 702, 703, 704, 705, 706, 707 and 708 are erected, and which is more particularly shaded in Plan 1.



All that part of the housing estate of the Board bounded by Cambridge Road, Owen Road and Durham Road, comprised in Lot numbers 01478T, 01410L, 01789P and 01530L in TS 18 and on which Apartment Blocks 41, 44, 45 and 46 are erected, and in Lot number 01479A in TS 18 and on which Apartment Blocks 42 and 43 are erected, and which is more particularly shaded in Plan 2.



FRENCH ROAD/KING GEORGE'S AVENUE


