In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

**Citation**

1. This Notification is the Common Gaming Houses (Exemption) (No. 41) Notification 2016.

**Definition**

2. In this Notification, “organisers” means —
- (a) the Eunos Senior Citizens’ Executive Committee; and
  - (b) the Eunos Active Ageing Committee.

**Exemption**

3.—(1) The Minister exempts the organisers from the provisions of the Act in respect of —

- 
- 
- (a) the “Mahjong Challenge 2016” promotion to be held from 1 September 2016 to 2 October 2016 (both dates inclusive); and
- (b) the mahjong games to be held at the multi-purpose hall of Eunos Community Club from 9 a.m. to 4 p.m. on 2 October 2016.
- (2) The exemption is subject to compliance by the organisers with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 3

### CONDITIONS

1. The only game played must be mahjong.
2. All players must be at least 50 years of age and residing in such area within the Aljunied Group Representation Constituency as is designated by the organisers to be the Eunos district.
3. All spectators and staff must be at least 21 years of age.
4. Prize sponsors must not be involved in any business related to gambling.
5. Advertising for the mahjong competition must be confined to posters and banners displayed within the Eunos district.
6. The organisers may charge an entrance fee of \$5 for PAssion Card members and \$8 for non-PAssion Card members to cover the cost of hosting the mahjong competition, less the value of the prizes.
7. Token prizes can be allowed in recognition of the skills shown by the winners.
8. The organisers must ensure that the rules of the game are explained clearly to all players before the start of the event.
9. The organisers must deploy umpires on site to referee the event and resolve any disputes.
10. The mahjong activities must be held indoors at the multi-purpose hall of Eunos Community Club.
11. The organisers must ensure that all doors to the multi-purpose hall of Eunos Community Club are closed during the event so as to minimise noise from the event.

THE SCHEDULE — *continued*

12. The organisers must open up the premises for spot-checks by the police during the event.
13. The organisers must take all reasonable steps to ensure that there are no private deals or side-betting throughout the event.
