### ENDANGERED SPECIES (IMPORT AND EXPORT) ACT (CHAPTER 92A)

### ENDANGERED SPECIES (IMPORT AND EXPORT) ACT (AMENDMENT OF SCHEDULE) (NO. 2) NOTIFICATION 2014

In exercise of the powers conferred by section 28 of the Endangered Species (Import and Export) Act, the Minister for National Development hereby makes the following Notification:

#### Citation and commencement

1. This Notification may be cited as the Endangered Species (Import and Export) Act (Amendment of Schedule) (No. 2) Notification 2014 and shall come into operation on 24th June 2014.
