
Declaration of precincts for Home Improvement Programme



ANG MO KIO AVENUE 3/ANG MO KIO AVENUE 10





PLAN 2 BEDOK RESERVOIR ROAD





PLAN 3 HOUGANG AVENUE 1/HOUGANG STREET 21





PLAN 4 SERANGOON AVENUE 2/SERANGOON AVENUE 3




