In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) Order 2017 and comes into operation on 3 February 2017.

**Declaration of precincts for Home Improvement Programme**

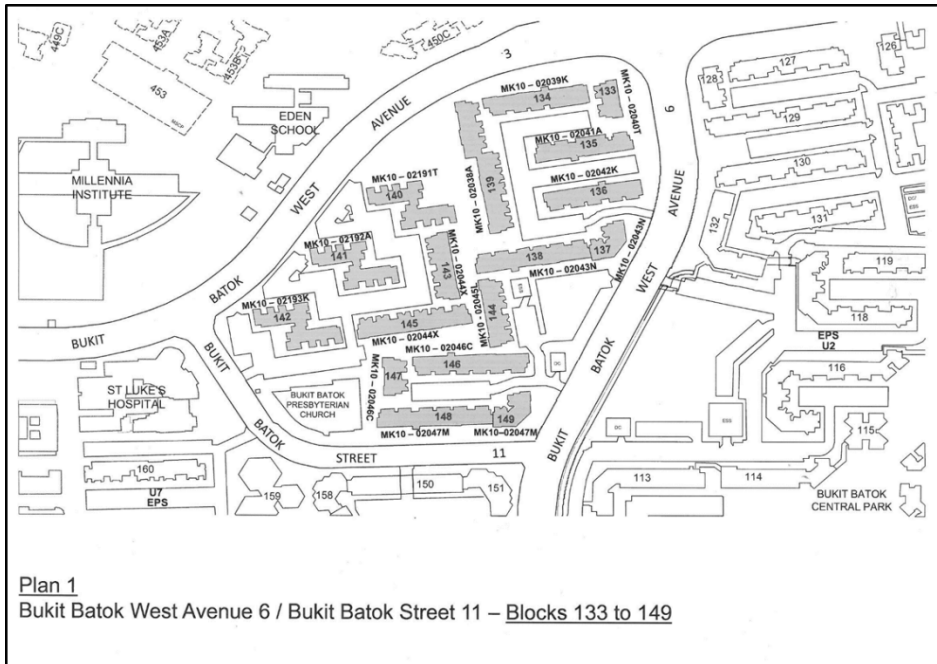
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Bukit Batok West Avenue 3, Bukit Batok West Avenue 6 and Bukit Batok Street 11, comprised in Lot numbers 02040T, 02039K, 02041A, 02042K, 02038A, 02191T, 02192A, 02193K and 02045L in Mukim 10 and on which Apartment Blocks 133, 134, 135, 136, 139, 140, 141, 142 and 144 are erected, in Lot number 02043N in Mukim 10 and on which Apartment Blocks 137 and 138 are erected, in Lot number 02044X in Mukim 10 and on which Apartment Blocks 143 and 145 are erected, in Lot number 02046C in Mukim 10 and on which Apartment Blocks 146 and 147 are erected, and in Lot number 02047M in Mukim 10 and on which Apartment Blocks 148 and 149 are erected, and which is more particularly shaded in Plan 1.

BUKIT BATOK WEST AVENUE 6/BUKIT BATOK STREET 11

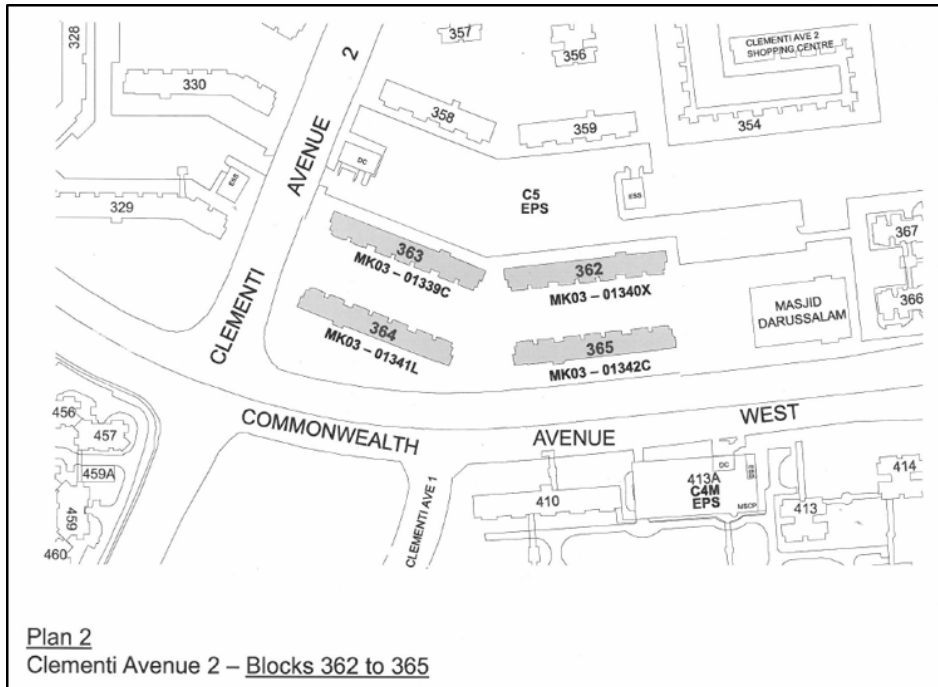

## CLEMENTI AVENUE 2

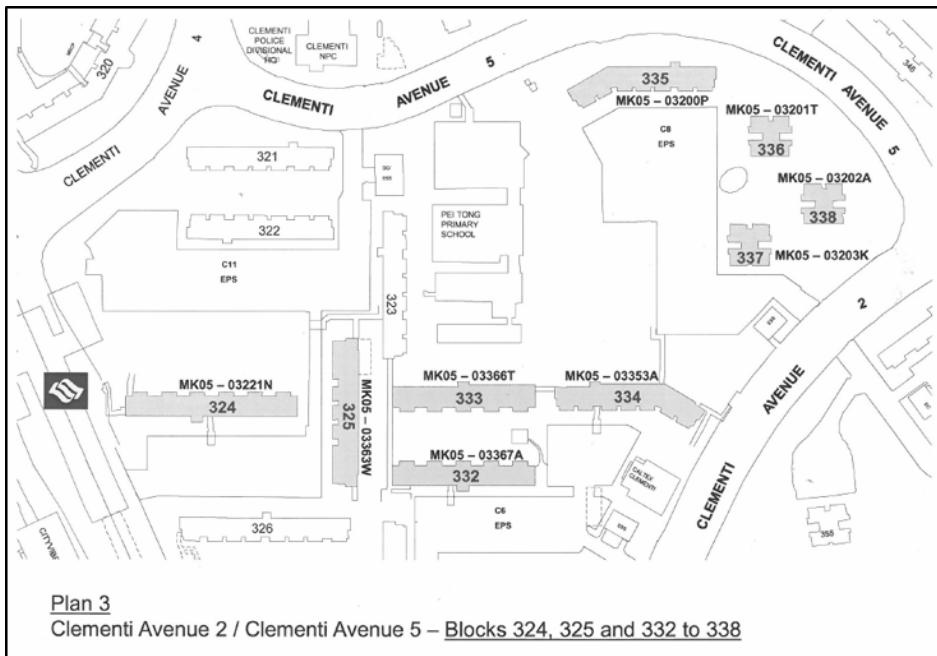

## CLEMENTI AVENUE 2/CLEMENTI AVENUE 5

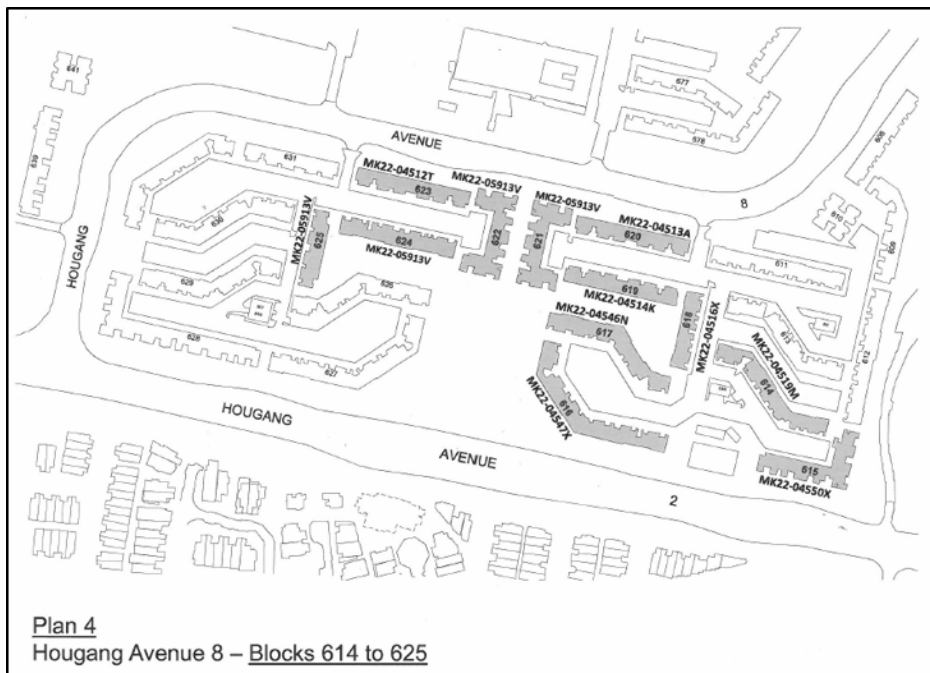

## HOUGANG AVENUE 8

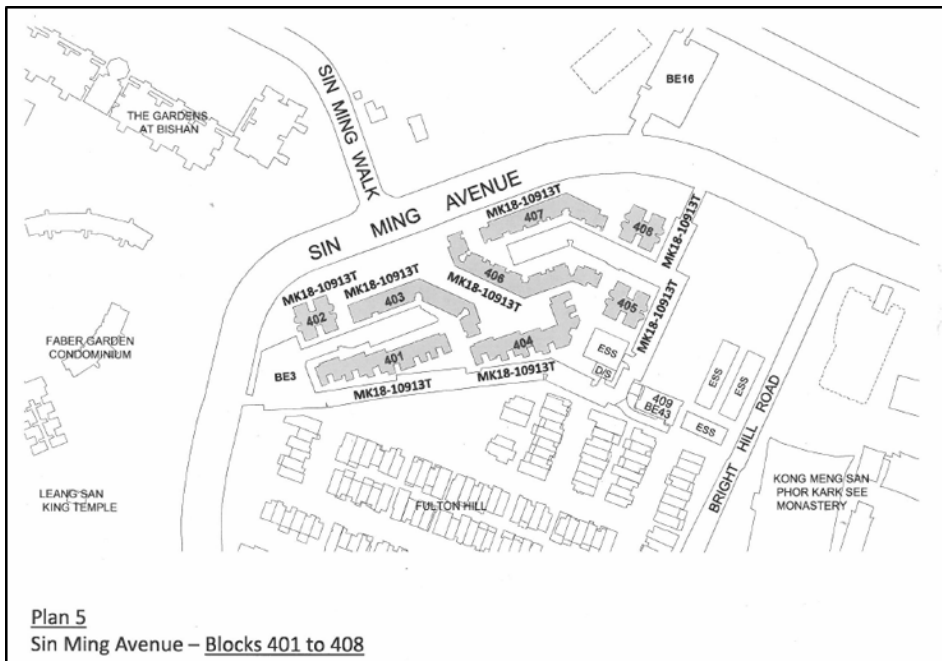

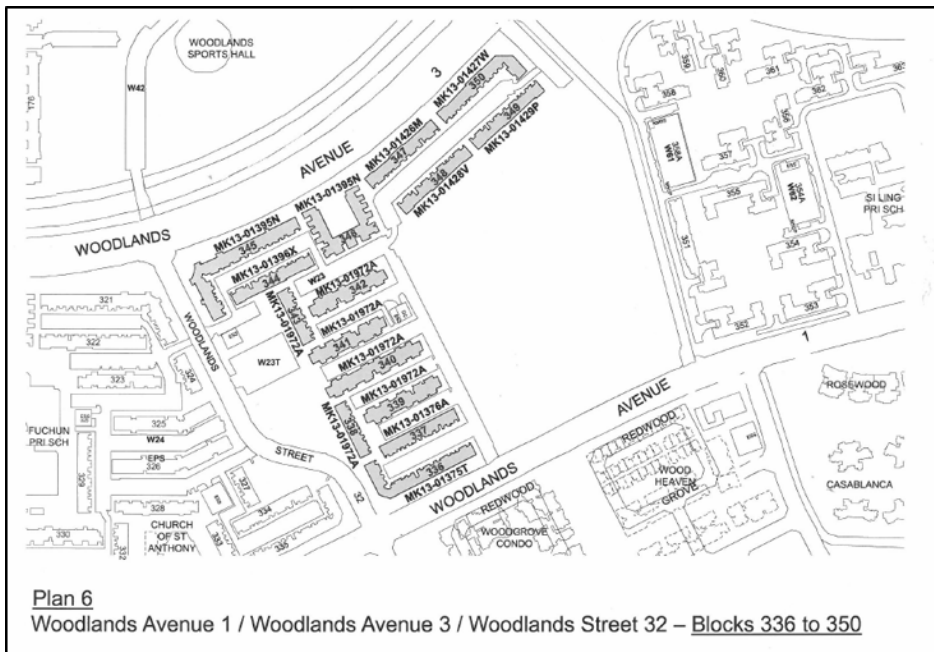
## SIN MING AVENUE
