### AIR NAVIGATION ACT 1966

#### AIR NAVIGATION (135 — COMMERCIAL AIR TRANSPORT BY HELICOPTERS AND SMALL AEROPLANES) (AMENDMENT) REGULATIONS 2024

In exercise of the powers conferred by section 9 of the Air Navigation Act 1966, the Civil Aviation Authority of Singapore, with the approval of the Minister for Transport, makes the following Regulations:

#### **Citation and commencement**

1. These Regulations are the Air Navigation (135 — Commercial Air Transport by Helicopters and Small Aeroplanes) (Amendment) Regulations 2024 and come into operation on 17 June 2024.

#### **Amendment of regulation 36**

2. In the Air Navigation (135 — Commercial Air Transport by Helicopters and Small Aeroplanes) Regulations 2018 (G.N. No. S 445/2018) (called in these Regulations the principal Regulations), in regulation 36(a), replace “paragraph 67 of the Air Navigation Order” with “the Air Navigation (139 — Aerodromes) Regulations 2023 (G.N. No. S 10/2023)”.

#### **Amendment of regulation 127**

3. In the principal Regulations, in regulation 127 —
- (a) in paragraphs (a) and (aa), after “assess”, insert “continuing”; and
  - (b) in paragraph (aa), after “from the”, insert “individual or”.

**Amendment of regulation 140**

4. In the principal Regulations, in regulation 140(2)(b), replace “approved by the Director-General of Civil Aviation to supervise such use” with “appointed as a training instructor in accordance with the process specified in regulation 142”.

**Amendment of regulation 142**

5. In the principal Regulations, in regulation 142 —

(a) replace paragraph (1) with —

“(1) An AOC holder must have a process that is approved by the Director-General of Civil Aviation, for appointing training instructors.”;

(b) in paragraph (2)(b), delete “and” at the end;

(c) in paragraph (2)(c), replace the full-stop at the end with “; and”; and

(d) in paragraph (2), after sub-paragraph (c), insert —

“(d) the type of simulation equipment or apparatus that an appointed training instructor is trained to use and to supervise the use of.”.
