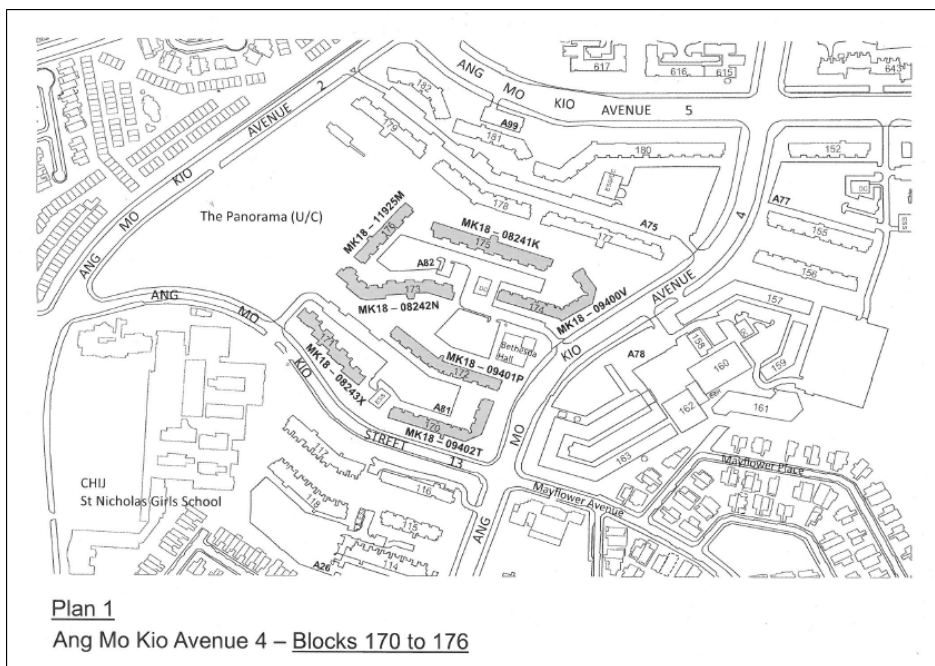

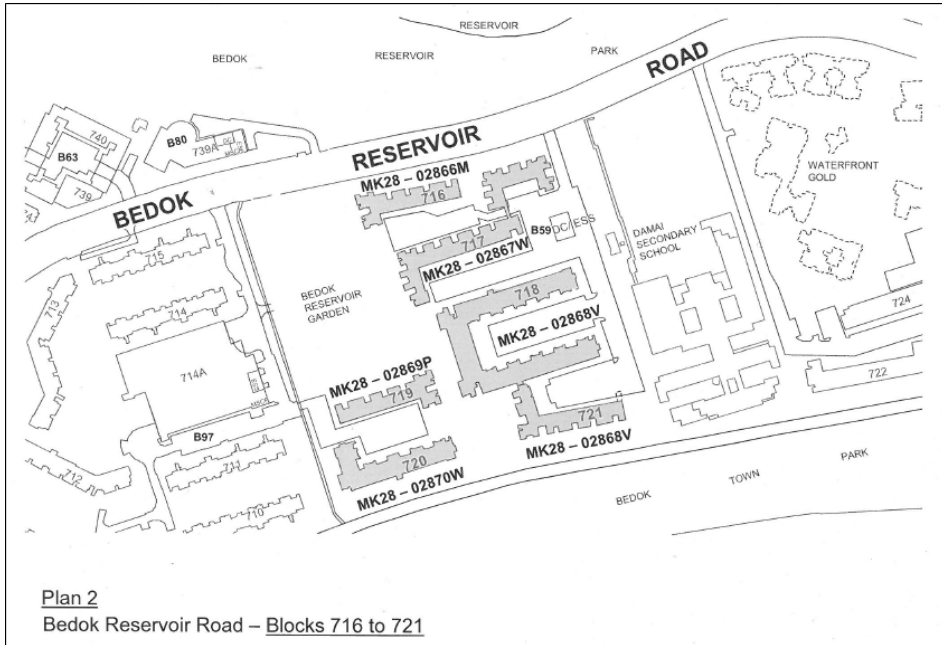
ANG MO KIO AVENUE 4

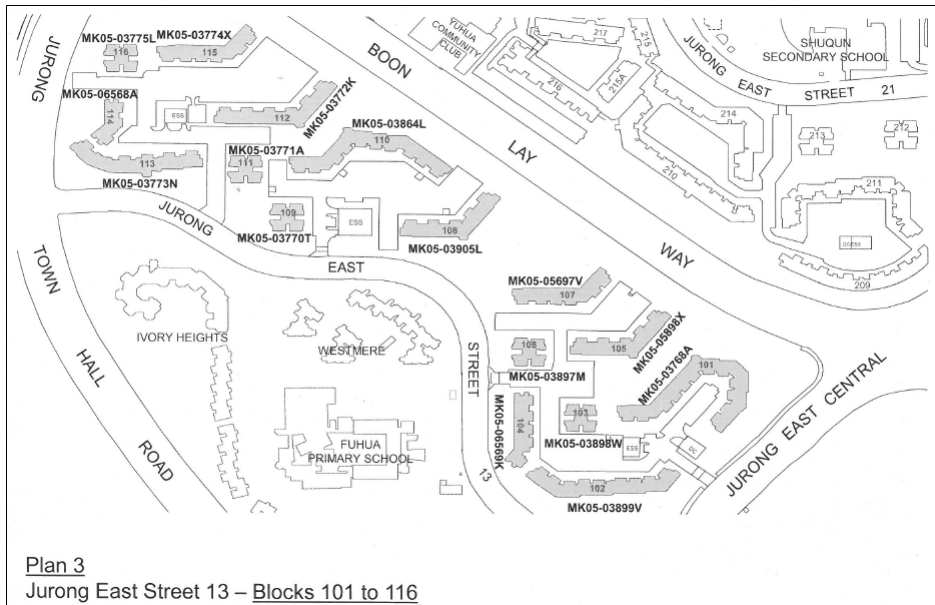

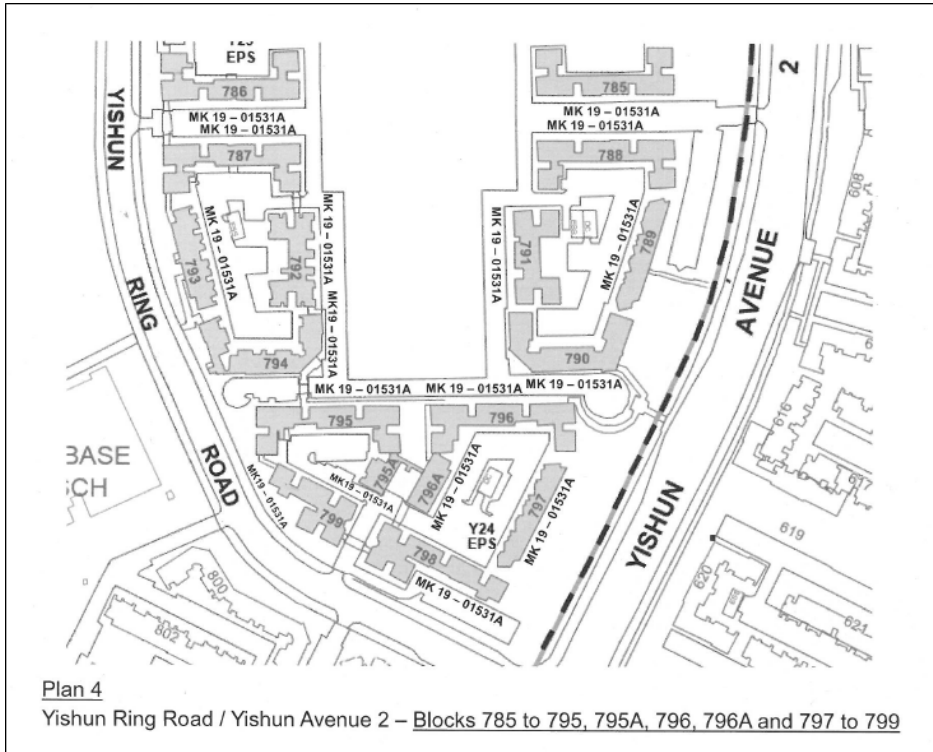

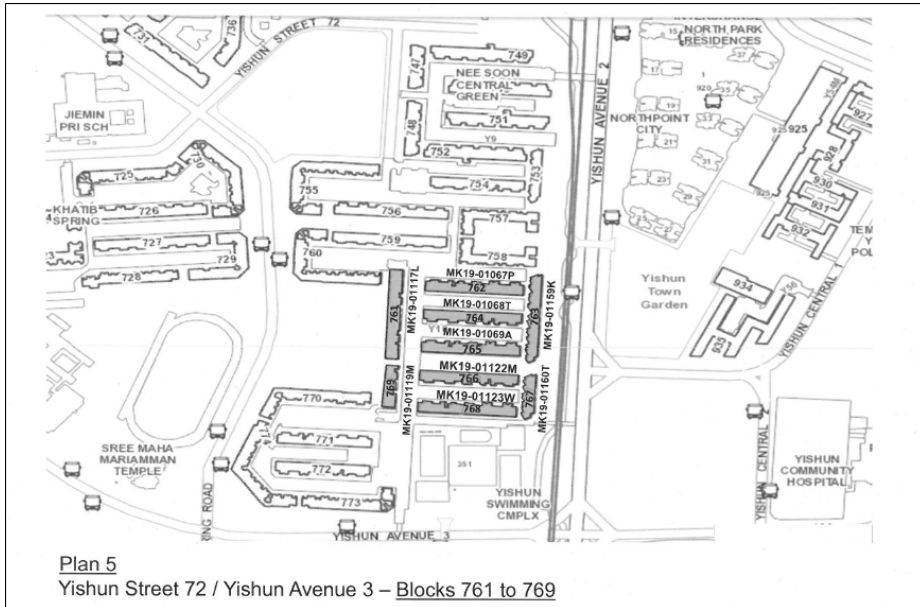
