ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 32) Notification 2013.

Exemption

2.—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of the “Ruby Room Fiesta” promotion to be held from 17th July 2013 to 22nd September 2013 (both dates inclusive), comprising the following promotions and draws to be held at the Ruby Room at Marina Bay Sands:

- (a) the “Taste of Ruby” promotion to be held from 4 p.m. to 9.45 p.m. on every Monday between 29th July 2013 and 16th September 2013 (both dates inclusive);

- (b) the “Mega Ruby Wheel” promotion to be held from 10 a.m. to 9.45 p.m. on every Tuesday between 30th July 2013 and 17th September 2013 (both dates inclusive);
- (c) the “Ruby Rewards” promotion to be held from 10 a.m. to 9.45 p.m. on every Wednesday between 31st July 2013 and 18th September 2013 (both dates inclusive);
- (d) the “Ruby Star Players” promotion to be held from 4 p.m. to 9.45 p.m. on every Thursday between 1st August 2013 and 19th September 2013 (both dates inclusive) and the “Ruby Star Players Finale” promotion to be held from 4 p.m. to 9.45 p.m. on 19th September 2013; and
- (e) the “Treasures of Ruby” promotion to be held from 4 p.m. to 9.30 p.m. on every Friday, Saturday and Sunday between 2nd August 2013 and 22nd September 2013 (both dates inclusive) and the draws to be held at 6 p.m., 8 p.m. and 10 p.m., respectively, during those days.
- (2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
2. Every draw shall be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
3. Every draw shall be conducted in public.
4. Every draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
5. Every draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.

THE SCHEDULE — *continued*

6. Every draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
7. Marina Bay Sands Pte. Ltd. shall, before the start of any of the draws, undertake to ensure that —
 - (a) the results of the draws will be announced via the AV system at the draw area, in addition to being displayed on the casino's plasma television sets, after each draw is completed; and
 - (b) an audited statement of accounts shall, together with the results of the draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 23rd December 2013.
