(CHAPTER 305C)

SINGAPORE TOURISM
(TOURIST HOTELS, TOURIST FOOD ESTABLISHMENTS
AND TOURIST PUBLIC HOUSES) (AMENDMENT)
NOTIFICATION 2011

In exercise of the powers conferred by the definitions of “tourist hotel”, “tourist food establishment” and “tourist public house” in section 2 of the Singapore Tourism (Cess Collection) Act, the Minister for Trade and Industry hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Singapore Tourism (Tourist Hotels, Tourist Food Establishments and Tourist Public Houses) (Amendment) Notification 2011 and shall come into operation on 4th August 2011.

Amendment of Schedule

2. The Schedule to the Singapore Tourism (Tourist Hotels, Tourist Food Establishments and Tourist Public Houses) Notification (N 1) is amended —

- (i) by deleting the words “Rasa Sentosa Resort, Singapore” in item (79) and substituting the words “Shangri-La’s Rasa Sentosa Resort, Singapore”;
- (j) by deleting item (81) relating to Treasure Resort;
- (k) by deleting the words “The Sentosa, Resort & Spa” in item (88) and substituting the words “The Sentosa Resort & Spa”;
- (l) by deleting the words “The Royal Peacock” in item (98) and substituting the words “The Saff”;
- (m) by deleting the words “Fragrance Hotel Imperial” in item (117) and substituting the words “Fragrance Hotel — Imperial”;
- (n) by deleting the words “Crowne Plaza Changi Airport Hotel” in item (120) and substituting the words “Crowne Plaza Changi Airport”;
- (o) by deleting item (124) relating to Cityhub Hotel;
- (p) by deleting the words “Sloane Court” in item (152) and substituting the words “Sloane Court Hotel”;
- (q) by deleting the words “Hotel 81 Osaka” in item (168) and substituting the words “Hotel 81 — Osaka”; and
- (r) by inserting, immediately after item (180), the following items:
