Citation and commencement

1. This Order is the Housing and Development (Precincts for Lift Upgrading Works) (No. 10) Order 2016 and comes into operation on 29 September 2016.

Declaration of precincts for lift upgrading works

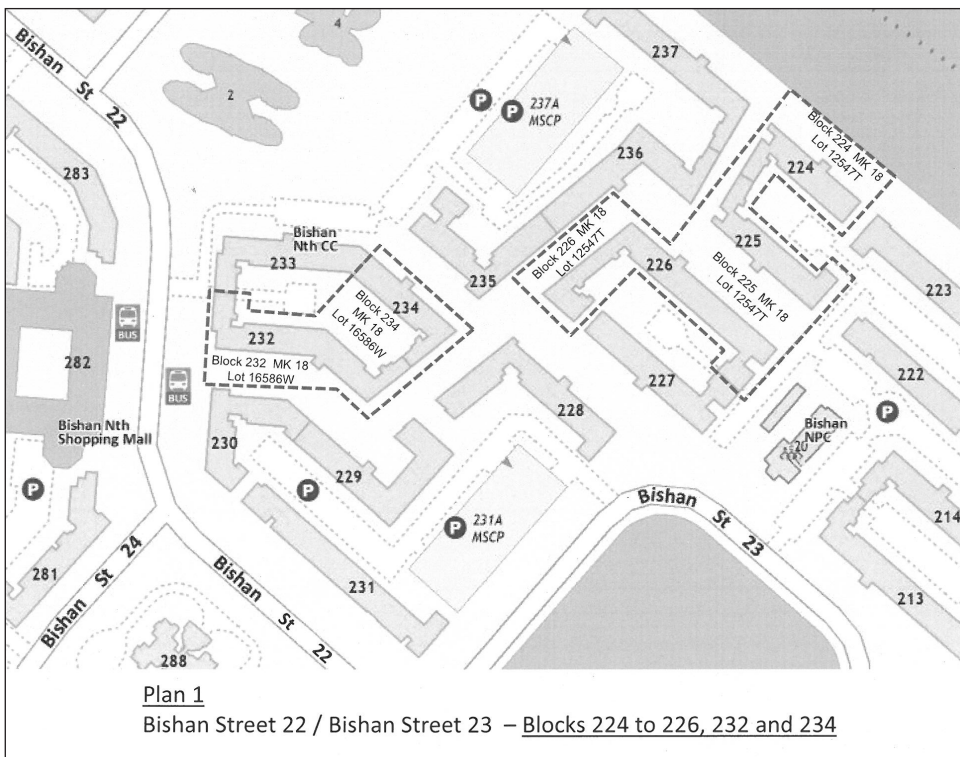
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out lift upgrading works.

All that part of the housing estate of the Board bounded by Bishan Street 22 and Bishan Street 23, comprised in Lot number 12547T in Mukim 18 and on which Apartment Blocks 224, 225 and 226 are erected, and in Lot number 16586W in Mukim 18 and on which Apartment Blocks 232 and 234 are erected, and which is more particularly delineated in Plan 1.

BISHAN STREET 22/BISHAN STREET 23

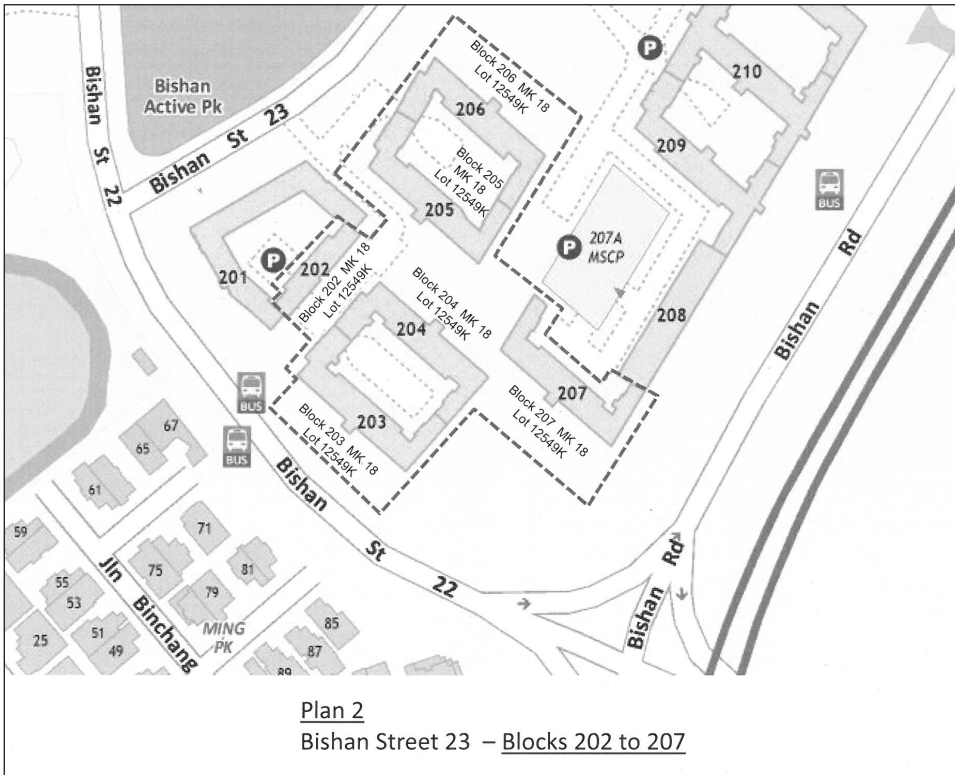

BISHAN STREET 23

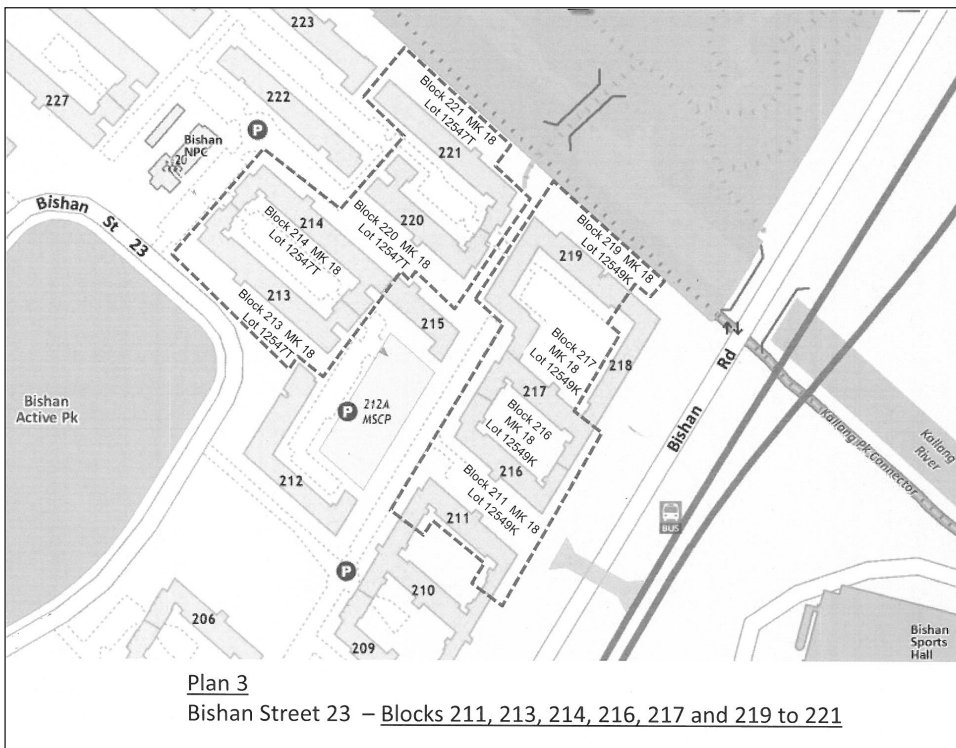

BISHAN STREET 23

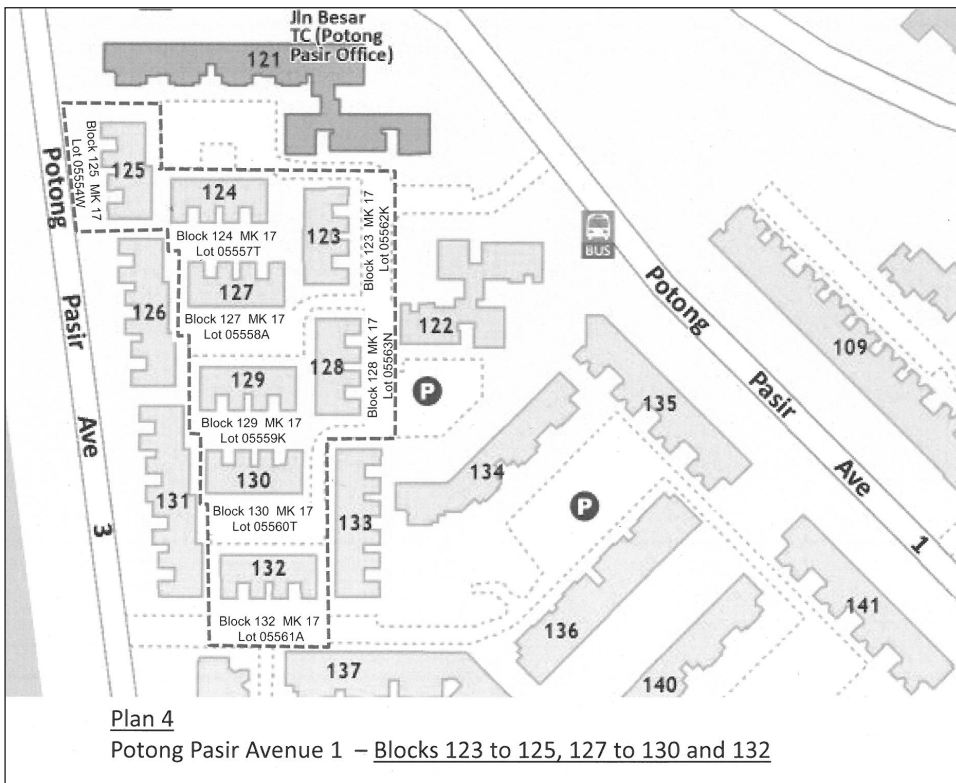

POTONG PASIR AVENUE 1

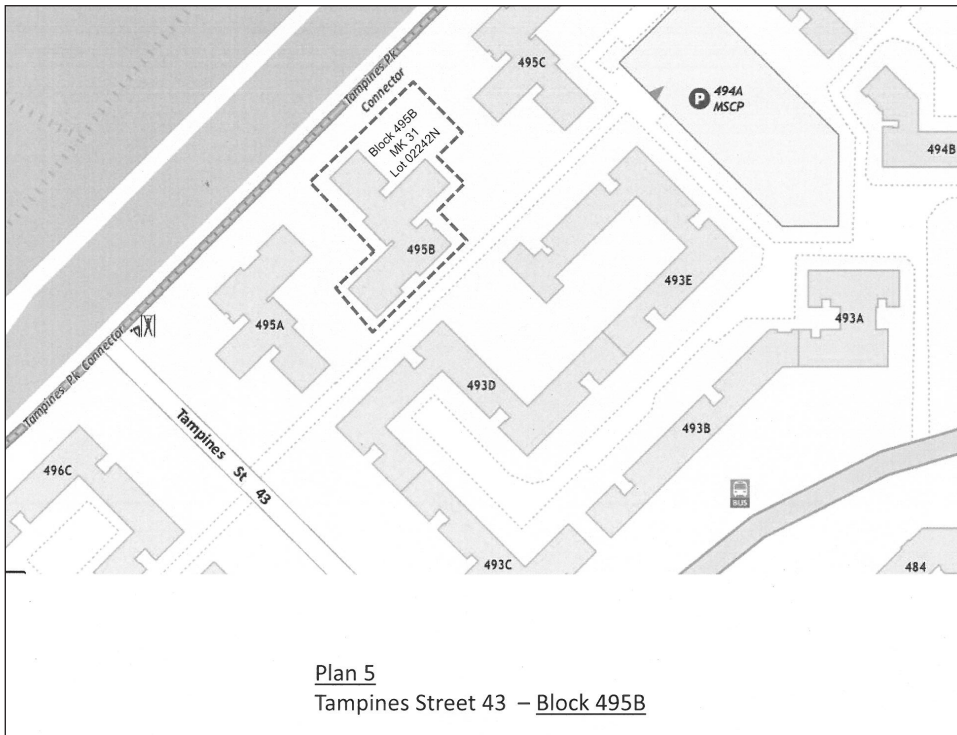

TAMPINES STREET 43

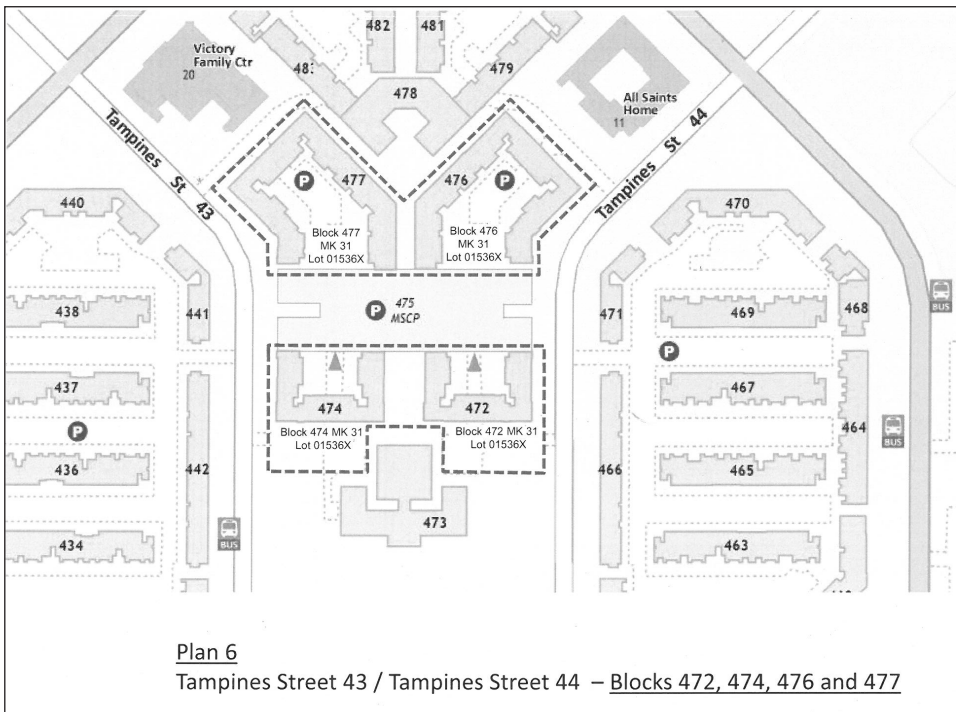
