INFECTIOUS DISEASES
(DECLARATION OF ISOLATION AREA)
(MISCELLANEOUS AMENDMENTS) NOTIFICATION 2020

In exercise of the powers conferred by section 17(1) of the Infectious Diseases Act, the Minister for Health makes the following Notification:

Citation and commencement

1. This Notification is the Infectious Diseases (Declaration of Isolation Area) (Miscellaneous Amendments) Notification 2020 and comes into operation on 10 June 2020.

Amendment of Infectious Diseases (Declaration of Isolation Area) Notification 2020

2. Paragraph 2 of the Infectious Diseases (Declaration of Isolation Area) Notification 2020 (G.N. No. S 248/2020) is deleted and the following paragraph substituted therefor:

“Declaration of isolation area

2. Each of the following premises of the foreign employee dormitory known as PPT Lodge 1B is declared to be an isolation area for the purpose of preventing the spread or possible outbreak of the infectious disease COVID-19:
