In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 4) Order 2019 and comes into operation on 28 June 2019.

**Declaration of precincts for Home Improvement Programme**


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

## THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Ang Mo Kio Avenue 4, Ang Mo Kio Avenue 9 and Ang Mo Kio Street 61, comprised in Lot numbers 07940X, 07943M, 07941L, 07944W, 07942C, 07945V, 11939M, 12577P, 12578T, 09331A and 12579A in Mukim 18 and on which Apartment Blocks 620, 621, 622, 623, 624, 625, 627, 629, 630, 631 and 632 are erected, and which is more particularly shaded in Plan 1.


#### ANG MO KIO AVENUE 4/ANG MO KIO AVENUE 9

BEDOK RESERVOIR ROAD



## BUKIT BATOK STREET 21/BUKIT BATOK EAST AVENUE 3



## HOUGANG AVENUE 6/HOUGANG AVENUE 10/HOUGANG CENTRAL



## JURONG WEST STREET 41



## TAMPINES STREET 21


