**ROAD TRAFFIC ACT  
(CHAPTER 276)**

**RESTRICTION OF SPEED (ROADS)  
(AMENDMENT NO. 3) NOTIFICATION 2000**

In exercise of the powers conferred by section 63 (2) of the Road Traffic Act, the Minister for Home Affairs hereby makes the following Notification:

**Citation and commencement**

**1.** This Notification may be cited as the Restriction of Speed (Roads) (Amendment No. 3) Notification 2000 and shall come into operation on 16th October 2000.

**Amendment of First Schedule**

**2.** The First Schedule to the Restriction of Speed (Roads) Notification (N 6) (referred to in this Notification as the principal Notification) is amended by inserting, immediately after Part 41, the following Part:

“PART 42

*Pulau Ubin*

Jalan Batu Ubin.

Jalan Durian.

Jalan Endut Senin.

Jalan Jelutong.

Jalan Mamam.

Jalan Noordin.

Jalan Pekan Ubin.

Jalan Sam Heng.

Jalan Ubin.

Jalan Wat Siam.

Lorong Bin Kiang.”.

### **Amendment of Fourth Schedule**

**3.** The Fourth Schedule to the principal Notification is amended by deleting the item relating to “Pan Island Expressway”, and substituting the following items:

“Pan Island Expressway — that part of Pan Island Expressway —

- (a) between lamp post No. 280 and lamp post No. 234, in the direction towards East Coast Parkway;
- (b) between lamp post No. 233 and lamp post No. 281, in the direction towards Ayer Rajah Expressway;
- (c) between lamp post No. 1276 F and lamp post No. 598, in the direction towards East Coast Parkway;
- (d) between lamp post No. 597 and lamp post No. 1281, in the direction towards Ayer Rajah Expressway;
- (e) between lamp post No. 2080 and lamp post No. 1928, in the direction towards East Coast Parkway; and
- (f) between lamp post No. 1925 and lamp post No. 2081, in the direction towards Ayer Rajah Expressway.

Seletar Expressway — that part of Seletar Expressway —

- (a) between lamp post No. 17 F and lamp post No. 103, in the direction towards Bukit Timah Expressway; and
- (b) between lamp post No. 74 and lamp post No. 16 F, in the direction towards Central Expressway.”.

### **Amendment of Fifth Schedule**

**4.** The Fifth Schedule to the principal Notification is amended by inserting, immediately after the item relating to “Kranji Expressway”, the following item:

“Pan Island Expressway — that part of Pan Island Expressway —

- (a) between lamp post No. 234 and lamp post No. 2 F2, in the direction towards East Coast Parkway;
- (b) between lamp post No. F57 and lamp post No. 233, in the direction towards Ayer Rajah Expressway;
- (c) between lamp post No. 598 and lamp post No. 280, in the direction towards East Coast Parkway;
- (d) between lamp post No. 281 and lamp post No. 597, in the direction towards Ayer Rajah Expressway;

- (e) between lamp post No. 1928 and lamp post No. 1276 F, in the direction towards East Coast Parkway; and
- (f) between lamp post No. 1281 and lamp post No. 1925, in the direction towards Ayer Rajah Expressway.”.
