# REMOTE GAMBLING (EXEMPTION) (NO. 3) ORDER 2018

#### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 40 of the Remote Gambling Act 2014, the Minister for Home Affairs makes the following Order:

#### Citation

**1.** This Order is the Remote Gambling (Exemption) (No. 3) Order 2018.

#### **Definitions**

- 2. In this Order, unless the context otherwise requires
  - "draw" means the draw to be held at 11 a.m. on 6 August 2018 at 80 Anson Road, #11-08, Singapore 079907, as part of the promotion;
  - "organiser" means the National Parks Board established by the repealed National Parks Act (Cap. 198A, 1991 Ed.) in force before 1 July 1996 and continued by section 3 of the National Parks Board Act (Cap. 198A);

"promotion" means the promotion called "Singapore Garden Festival @sggardenfest Social Media Contest 2018" that is to be made available from 21 July 2018 to 3 August 2018 (both dates inclusive) on the Facebook and Instagram social media platforms maintained by the organiser;

"public accountant" has the meaning given by section 2(1) of the Accountants Act (Cap. 2).

### **Exemption**

- **3.**—(1) The organiser is exempt from sections 11, 13, 15 and 17 of the Act in respect of the promotion and the draw.
- (2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

#### THE SCHEDULE

Paragraph 3(2)

#### CONDITIONS

- 1. All the following details must be included in publicity material that must be freely accessible to every participant of the draw:
  - (a) the name and address of the organiser;
  - (b) the details of the prizes to be distributed;
  - (c) the manner in which the prizes will be distributed;
  - (d) the time, date and place of the draw;
  - (e) how a person may participate in the draw;
  - (f) the manner in which the draw is to be conducted.
- 2. The organiser must keep a record of the name and email address of every winner of the draw.
- 3. Only persons in the employment of the organiser may conduct the draw.
- 4. The draw must
  - (a) be conducted in public; or
  - (b) if conducted in private by means of a computerised system, be witnessed and audited by a public accountant who is not in the employment of the organiser.

#### THE SCHEDULE — continued

- 5. The organiser must undertake to ensure that
  - (a) every winner is notified by email; and
  - (b) the results of the draw are published on both of the following websites:
    - (i) the Singapore Garden Festival Facebook Page at https://www.facebook.com/SGGardenFest/;
    - (ii) the Singapore Garden Festival Instagram Page at https://www.instagram.com/sggardenfest/.
- 6. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 7 November 2018.
