COMMON GAMING HOUSES (NANYANG TECHNOLOGICAL UNIVERSITY CULTURAL ACTIVITIES CLUB — EXEMPTION) NOTIFICATION 2022

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act 1961, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Nanyang Technological University Cultural Activities Club — Exemption) Notification 2022.

Exemption

- **2.**—(1) The Minister exempts the Nanyang Technological University Cultural Activities Club (Arts from the Heart) (called in this Notification the organiser) from the provisions of the Act in respect of
 - (a) the "AFTH Carnival 2022: Blast From The Past" promotion to be held from 17 June 2022 to 19 June 2022 (both dates inclusive); and
 - (b) the draws to be held as part of the promotion at City Square Mall, 180 Kitchener Road, Singapore 208539 on the following times and dates:

- (i) 4 p.m. and 7 p.m. on 18 June 2022;
- (ii) 4 p.m. and 7 p.m. on 19 June 2022.
- (2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2(2)

CONDITIONS

- 1. A draw ticket must only be issued by way of sale and upon receipt of its price in full.
- 2. All the following details must be freely accessible to every participant of a draw:
 - (a) the name and address of the organiser;
 - (b) the details of the prizes to be distributed;
 - (c) the time, date and place of the draw.
- 3. The organiser must keep a record of the name and contact number of every participant of a draw.
- 4. Each draw must be conducted in public by the organiser and persons in the employment of the organiser.
- 5. A draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
- 6. A draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 7. The organiser must, before the start of the draws, undertake to ensure that an audited statement of accounts and the results of the draws are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, Singapore Police Force, no later than 20 September 2022.
