ROAD TRAFFIC
(ELECTRONIC ROAD PRICING SYSTEM)
(AMENDMENT) RULES 2018

In exercise of the powers conferred by section 34D of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 2018 and come into operation on 6 August 2018.

Amendment of First Schedule

2. Part 20 of the First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended by deleting Division 2 and substituting the following Division:
