### GOVERNMENT CONTRACTS ACT (CHAPTER 118)

#### GOVERNMENT CONTRACTS (AUTHORISATION) (AMENDMENT NO. 2) NOTIFICATION 2015

In exercise of the powers conferred by section 2 of the Government Contracts Act, the Minister for Finance makes the following Notification:

#### **Citation and commencement**

1. This Notification may be cited as the Government Contracts (Authorisation) (Amendment No. 2) Notification 2015 and comes into operation on 20 August 2015.
