## CENTRAL PROVIDENT FUND ACT (AMENDMENT OF FIRST SCHEDULE) (NO. 2) NOTIFICATION 2011

In exercise of the powers conferred by section 7(8) of the Central Provident Fund Act, the Minister for Manpower hereby makes the following Notification:

## Citation and commencement

1. This Notification may be cited as the Central Provident Fund Act (Amendment of First Schedule) (No. 2) Notification 2011 and shall come into operation on 1st September 2011.
