Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 6) Order 2019 and comes into operation on 2 August 2019.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

All that part of the housing estate of the Board bounded by Jalan Damai and Bedok Reservoir Road, comprised in Lot number 06786L in Mukim 28 and on which Apartment Blocks 122, 123, 124, 125, 126, 127, 128, 129, 130, 131, 132, 133, 134 and 135 are erected, and in Lot numbers 05322C and 05323M in Mukim 28 and on which Apartment Blocks 631 and 632 are erected, and which is more particularly shaded in Plan 1.

BEDOK RESERVOIR ROAD



HOUGANG AVENUE 7







HOUGANG STREET 11/HOUGANG STREET 21



HOUGANG STREET 22




JURONG EAST STREET 21

PANDAN GARDENS



SERANGOON AVENUE 4


