**Citation and commencement**

1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 16) Order 2012 and shall come into operation on 18th October 2012.

**Declaration of precincts for lift upgrading works**

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

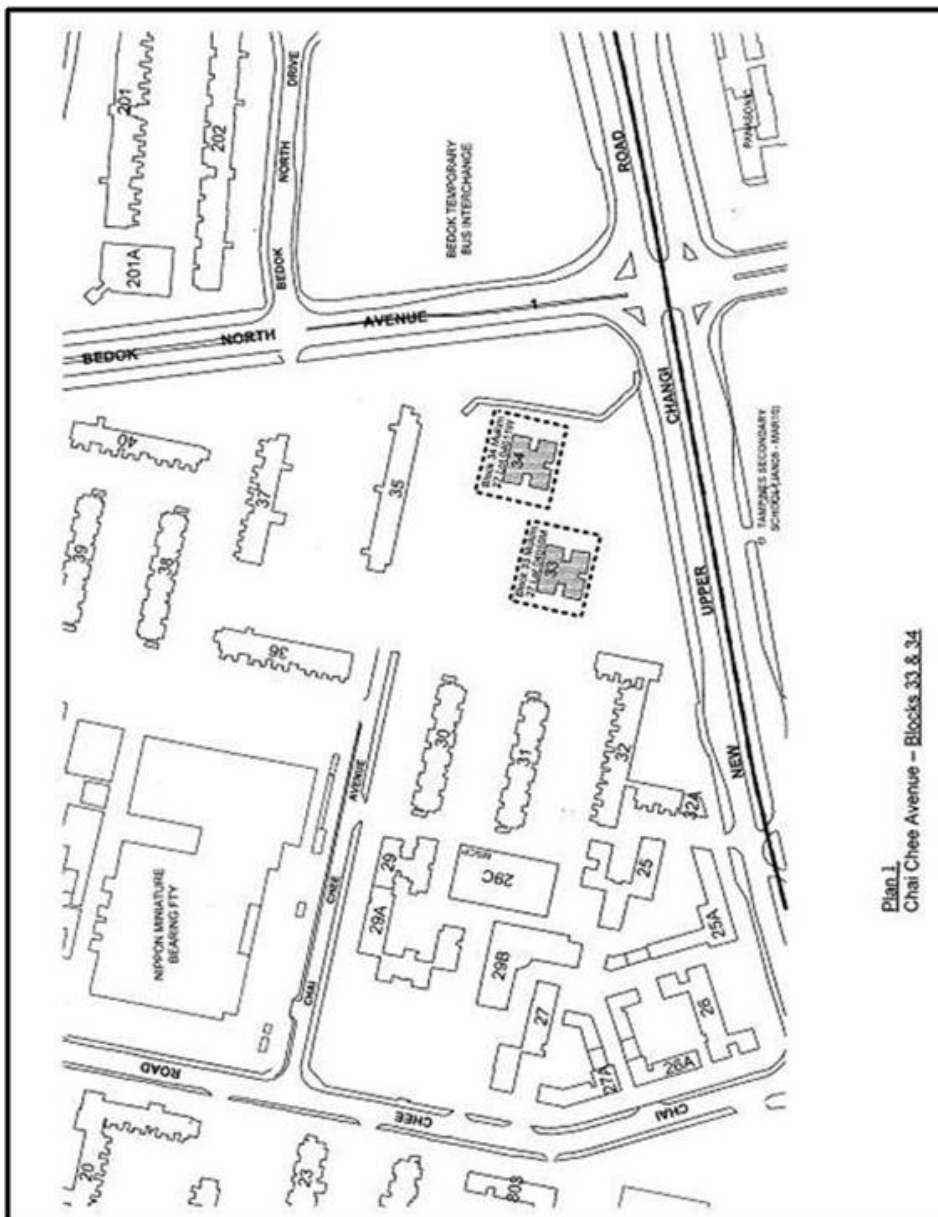
**THE SCHEDULE**

## CHAI CHEE AVENUE

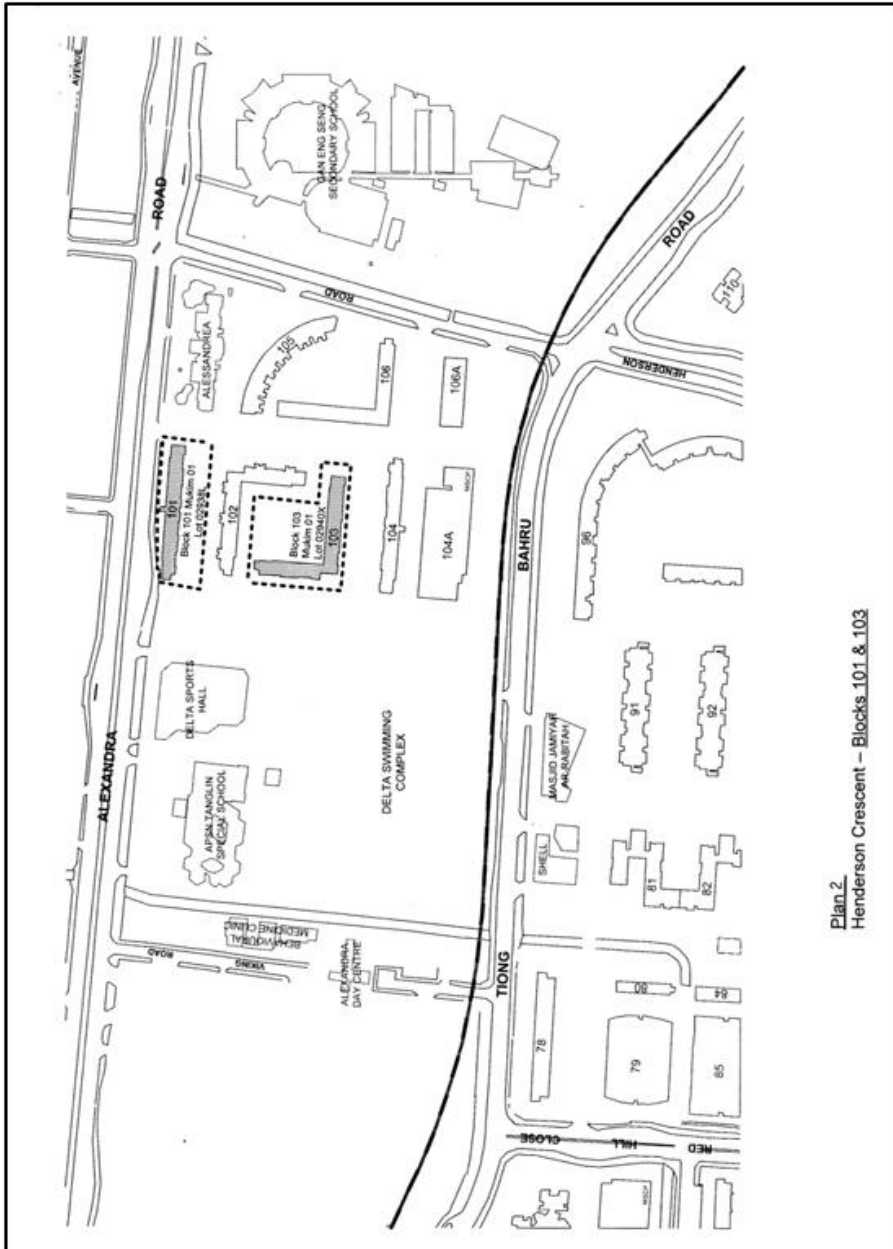

## HENDERSON CRESCENT



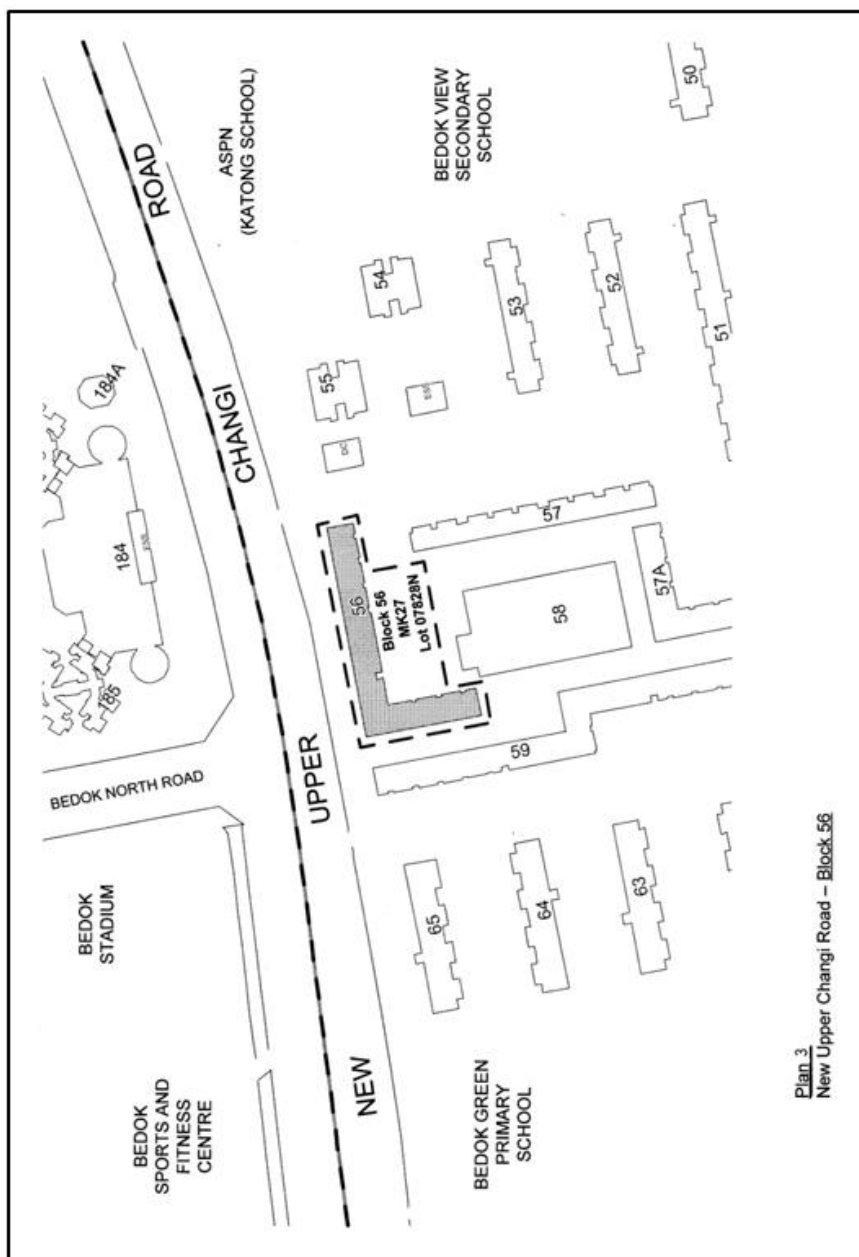
Plan 2.

## NEW UPPER CHANGI ROAD



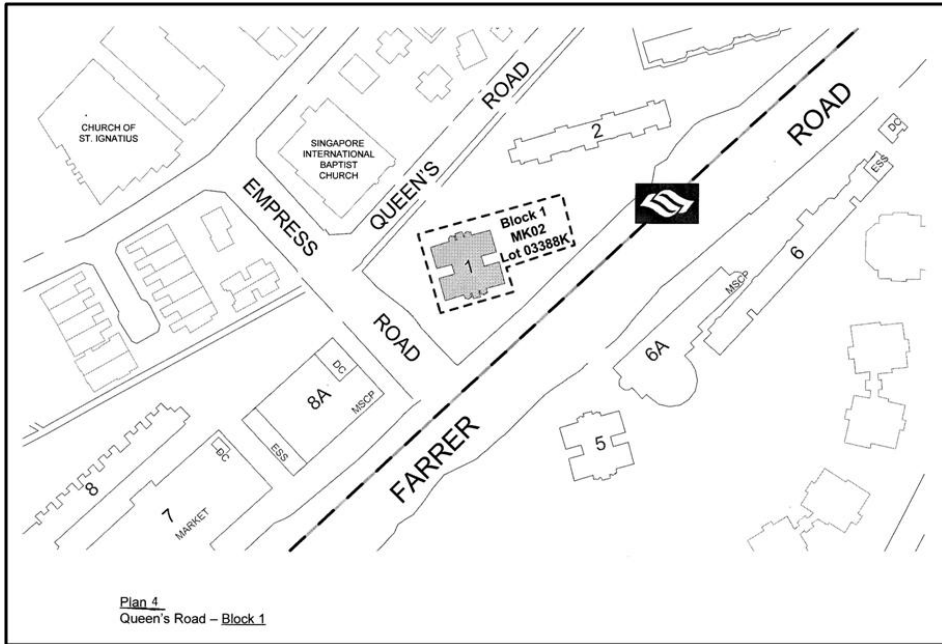
Plan 3
