### **CHILDREN AND YOUNG PERSONS ACT (CHAPTER 38)**

#### **CHILDREN AND YOUNG PERSONS (REVIEW BOARD) (AMENDMENT) REGULATIONS 2020**

In exercise of the powers conferred by section 88 of the Children and Young Persons Act, the Minister for Social and Family Development makes the following Regulations:

#### **Citation and commencement**

1. These Regulations are the Children and Young Persons (Review Board) (Amendment) Regulations 2020 and come into operation on 1 July 2020.

#### **Amendment of regulation 2**

2. Regulation 2 of the Children and Young Persons (Review Board) Regulations 2011 (G.N. No. S 412/2011) (called in these Regulations the principal Regulations) is amended by deleting the definitions of “Head” or “Head of Home” and “Manager”.

#### **Amendment of regulation 10**

3. Regulation 10 of the principal Regulations is amended —

- (a) by deleting the words “Head of a home, the Manager of a home,” and substituting the words “person-in-charge of a home”; and
- (b) by deleting the words “Head of Home, Manager of home” in the regulation heading and substituting the words “person-in-charge of home”.

**Amendment of regulation 11**

4. Regulation 11 of the principal Regulations is amended —
- (a) by deleting the word “Director” in paragraphs (1)(b) and (3)(d) and substituting in each case the word “Director-General”; and
  - (b) by deleting the words “Head of a home or the Manager of a home, as the case may be,” in paragraphs (2) and (3) and substituting in each case the words “person-in-charge of a home”.

**Amendment of regulation 12**

5. Regulation 12 of the principal Regulations is amended —
- (a) by deleting the words “Head of that home or the Manager of that home, as the case may be,” in paragraph (2)(b) and substituting the words “person-in-charge of the home”;
  - (b) by deleting the words “Head of that home or the Manager of that home” in paragraph (3) and substituting the words “person-in-charge of the home”; and
  - (c) by deleting the word “Director” in paragraphs (5) and (6) and substituting in each case the word “Director-General”.

**Amendment of regulation 14**

6. Regulation 14 of the principal Regulations is amended —
- (a) by deleting the words “Every Head of Home and every Manager of a home” and substituting the words “The person-in-charge of a home”; and
  - (b) by deleting the words “Head of Home” in the regulation heading and substituting the words “Person-in-charge of home”.
