ROAD TRAFFIC
(ELECTRONIC ROAD PRICING SYSTEM)
(AMENDMENT) RULES 2017

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment) Rules 2017 and come into operation on 20 February 2017.

Amendment of First Schedule

2. The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended —

(a) by deleting Division 2 of Part 21 and substituting the following Division:
