STRATEGIC GOODS (CONTROL) ACT (CHAPTER 300)

STRATEGIC GOODS (CONTROL) (AMENDMENT) REGULATIONS 2015

In exercise of the powers conferred by sections 36 and 38 of the Strategic Goods (Control) Act, the Minister for Trade and Industry makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Strategic Goods (Control) (Amendment) Regulations 2015 and come into operation on 2 November 2015.
