ROAD TRAFFIC ACT (CHAPTER 276)

ROAD TRAFFIC (RESTRICTION OF SPEED ON ROADS) (AMENDMENT) NOTIFICATION 2018

In exercise of the powers conferred by section 63(2) of the Road Traffic Act, the Minister for Transport makes the following Notification:

Citation and commencement

1. This Notification is the Road Traffic (Restriction of Speed on Roads) (Amendment) Notification 2018 and comes into operation on 8 September 2018.

Amendment of Part 1 of Second Schedule

2. Part 1 of the Second Schedule to the Road Traffic (Restriction of Speed on Roads) Notification (N 6) is amended —

(a) by inserting, immediately above the item relating to “Airport Boulevard Slip Road from Changi Airport Terminal 4 to East Coast Parkway”, the following item:

“Adam Underpass —

- (a) that part of the slip road from exit 20B of the Pan Island Expressway, between lamp post No. P1028/7(N) and its junction with Lornie Highway; and
- (b) that part of Lornie Highway between its junction with the slip road from exit 20B of the Pan Island Expressway and lamp post No. LP76/1(N).”;

- (b) by deleting the item relating to “Kheam Hock Road” and substituting the following item:

“Kheam Hock Road — that part of Kheam Hock Road excluding any part of Sime Underpass.”;

- (c) by inserting, immediately below the item relating to “Li Hwan Walk”, the following item:

“Lornie Underpass — that part of Lornie Road between lamp post No. P33S1(N) and lamp post No. P33S4(N), in the direction towards Sime Road.”; and

- (d) by inserting, immediately below the item relating to “Sime Road”, the following item:

“Sime Underpass —

- (a) that part of Kheam Hock Road between lamp post No. LP50(R) and its junction with Lornie Road; and
(b) that part of Lornie Road between its junction with Kheam Hock Road and lamp post No. P73S1(N).”.

Amendment of Fourth Schedule

- 3.** The Fourth Schedule to the Road Traffic (Restriction of Speed on Roads) Notification is amended by deleting the item relating to “Lornie Road” and substituting the following items:

“Lornie Highway — that part of Lornie Highway excluding any part of Adam Underpass.

Lornie Road — that part of Lornie Road excluding any part of Lornie Underpass and Sime Underpass.”.
