INFECTIOUS DISEASES  
(DECLARATION OF ISOLATION AREA)  
(MISCELLANEOUS AMENDMENTS) (NO. 4)  
NOTIFICATION 2020

In exercise of the powers conferred by section 17(1) of the Infectious Diseases Act, the Minister for Health makes the following Notification:

**Citation and commencement**

1. This Notification is the Infectious Diseases (Declaration of Isolation Area) (Miscellaneous Amendments) (No. 4) Notification 2020 and comes into operation on 7 July 2020.

**Amendment of Infectious Diseases (Declaration of Isolation Area) Notification 2020**

2. Paragraph 2 of the Infectious Diseases (Declaration of Isolation Area) Notification 2020 (G.N. No. S 248/2020) is amended —

- (a) by deleting sub-paragraphs (a) to (d) and (h) to (k); and
- (b) by deleting the semi-colon at the end of sub-paragraph (g) and substituting a full-stop.

**Amendment of Infectious Diseases (Declaration of Isolation Area) (No. 5) Notification 2020**

3. Paragraph 2 of the Infectious Diseases (Declaration of Isolation Area) (No. 5) Notification 2020 (G.N. No. S 260/2020) is amended —

- (a) by deleting sub-paragraphs (b) to (k), (m) and (n); and

(b) by deleting the semi-colon at the end of sub-paragraph (l) and substituting a full-stop.

**Amendment of Infectious Diseases (Declaration of Isolation Area) (Jurong Penjuru Dormitory 1) Notification 2020**

4. Paragraph 2 of the Infectious Diseases (Declaration of Isolation Area) (Jurong Penjuru Dormitory 1) Notification 2020 (G.N. No. S 297/2020) is amended by inserting, immediately before the words “56 Penjuru Place” in sub-paragraph (d), the words “Block 56A,”.

**Amendment of Infectious Diseases (Declaration of Isolation Area) (Changi Lodge 2) Notification 2020**

5. Paragraph 2 of the Infectious Diseases (Declaration of Isolation Area) (Changi Lodge 2) Notification 2020 (G.N. No. S 311/2020) is amended by deleting sub-paragraph (c).
