COMPANIES ACT (AMENDMENT OF SECOND SCHEDULE) NOTIFICATION 2006

In exercise of the powers conferred by section 8(6) of the Companies Act, the Minister for Finance hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Companies Act (Amendment of Second Schedule) Notification 2006 and shall come into operation on 30th January 2006.

 - (d) by deleting the word "non-redeemable" in item 32;
 - (e) by inserting, immediately after item 35, the following sub-headings and items:
