PUBLIC ORDER (ADDITIONAL TEMPORARY MEASURES) ACT 2014 (ACT 12 OF 2014)

PUBLIC ORDER (ADDITIONAL TEMPORARY MEASURES) (CLASS PERMIT) (AMENDMENT NO. 4) NOTIFICATION 2014

In exercise of the powers conferred by section 5(2) of the Public Order (Additional Temporary Measures) Act 2014, the Commissioner of Police hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Public Order (Additional Temporary Measures) (Class Permit) (Amendment No. 4) Notification 2014 and shall come into operation on 24 August 2014.

New paragraphs 6D and 6E

2. The Public Order (Additional Temporary Measures) (Class Permit) Notification 2014 (G.N. No. S 262/2014) is amended by inserting, immediately after paragraph 6C, the following paragraphs:

"Delivery, supply and consumption of alcohol during 7th Month Festival

- **6D.**—(1) The delivery, by Chuan Hoe Trading Co Pte Ltd on 24 August 2014 to the relevant area, of alcohol ordered under a contract of purchase by the organising committee in connection with the relevant event is authorised under this Notification.
- (2) Despite paragraph 6, the supply of alcohol by any member or staff of the organising committee on 24 August 2014 within the relevant area in connection with the relevant event is authorised under this Notification, subject to the following conditions:

- (a) no alcohol is supplied to any individual below the age of 18 years or to any individual who is apparently drunk;
- (b) the supply of alcohol is solely for consumption within the relevant area;
- (c) alcohol may only be supplied between 7.30 p.m. and 10.30 p.m. on that day (both times inclusive);
- (d) a notice is displayed in a prominent manner within the relevant area at points of exit, in the 4 official languages, informing the public that consumption of alcohol outside the relevant area on that day is an offence under the Act;
- (e) there are measures to ensure that no alcohol is taken out of the relevant area for consumption;
- (f) there are measures to prevent and minimise incidents of alcohol-related crime or other disorder occurring among the participants of the relevant event.
- (3) Despite paragraph 5, the consumption of alcohol between 7.30 p.m. and 11.59 p.m. on 24 August 2014 (both times inclusive) within the relevant area by a participant of the relevant event above 18 years of age is authorised under this Notification.
 - (4) In this paragraph
 - "member or staff of the organising committee" means an individual who wears a uniform which associates the individual with the relevant event, and who
 - (a) is part of the organising committee; or
 - (b) is employed by the organising committee, and is present within the relevant area to assist with the relevant event;
 - "organising committee" means the organising committee of the relevant event;
 - "participant", in relation to the relevant event, means
 - (a) a guest of the organising committee with an invitation to the relevant event; or

- (b) any member or staff of the organising committee; "relevant area" means
 - (a) the area within the tent erected in front of the buildings at No. 8 to No. 40 of Sam Leong Road; and
 - (b) the area within the tent erected in front of the buildings at No. 7 to No. 45 of Sam Leong Road;
- "relevant event" means the event known as "7th Month Festival" held on 24 August 2014 within the relevant area.

Delivery, supply and consumption of alcohol during Seven Moon Man Celebrations

- **6E.**—(1) The delivery, by Heng Tong Huat on 24 August 2014 to the relevant area, of alcohol ordered under a contract of purchase by the organising committee in connection with the relevant event is authorised under this Notification.
- (2) Despite paragraph 6, the supply of alcohol by any member or staff of the organising committee on 24 August 2014 within the relevant area in connection with the relevant event is authorised under this Notification, subject to the following conditions:
 - (a) no alcohol is supplied to any individual below the age of 18 years or to any individual who is apparently drunk;
 - (b) the supply of alcohol is solely for consumption within the relevant area;
 - (c) alcohol may only be supplied between 7 p.m. and 10.30 p.m. on that day (both times inclusive);
 - (d) a notice is displayed in a prominent manner within the relevant area at points of exit, in the 4 official languages, informing the public that consumption of alcohol outside the relevant area on that day is an offence under the Act;
 - (e) there are measures to ensure that no alcohol is taken out of the relevant area for consumption;

- (f) there are measures to prevent and minimise incidents of alcohol-related crime or other disorder occurring among the participants of the relevant event.
- (3) Despite paragraph 5, the consumption of alcohol between 7 p.m. and 11.59 p.m. on 24 August 2014 (both times inclusive) within the relevant area by a participant of the relevant event above 18 years of age is authorised under this Notification.
 - (4) In this paragraph
 - "member or staff of the organising committee" means an individual who possesses an identification document for the relevant event, and who
 - (a) is part of the organising committee; or
 - (b) is employed by the organising committee, and is present within the relevant area to assist with the relevant event;
 - "organising committee" means the organising committee of the relevant event;
 - "participant", in relation to the relevant event, means
 - (a) a guest of the organising committee with an invitation to the relevant event; or
 - (b) any member or staff of the organising committee;
 - "relevant area" means the area within the tent erected on the open field facing Kinta Road and adjacent to No. 38 Kinta Road;
 - "relevant event" means the event known as "Seven Moon Man Celebrations" held on 24 August 2014 within the relevant area.".
