# IMMIGRATION (AMENDMENT) REGULATIONS 2014

In exercise of the powers conferred by section 55(1) of the Immigration Act, the Minister for Home Affairs hereby makes the following Regulations:

## Citation and commencement

1. These Regulations may be cited as the Immigration (Amendment) Regulations 2014 and shall come into operation on 1 September 2014.

# Amendment of regulation 33A

**2.** Regulation 33A of the Immigration Regulations (Rg 1) is amended by inserting, immediately after "27H,", "27I, 27J, 27K, 27L,".

## **Amendment of First Schedule**

**3.** The First Schedule to the Immigration Regulations is amended by inserting, immediately after Form 27H, the following Forms:




