COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (EXEMPTION) (NO. 38) NOTIFICATION 2018

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (Exemption) (No. 38) Notification 2018.

Exemption

- 2.—(1) The Minister exempts the society registered under the Societies Act (Cap. 311) known as The Japanese Association, Singapore (UEN S62SS0062K) (called in this Notification the organiser) from the provisions of the Act in respect of
 - (a) the "2018 Charity Draw" promotion to be held from 13 September 2018 to 24 November 2018 (both dates inclusive); and
 - (b) the draw to be held as part of that promotion at 120 Adam Road, Singapore 289899 at 1.15 p.m. on 24 November 2018.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

- The price of the draw ticket, the name and address of the organiser, and the details of the prizes to be distributed, must be clearly stated on each draw ticket.
- 2. Each draw ticket must only be issued by way of sale and upon receipt of its price in full.
- 3. The name, membership number (if applicable), contact number and address (if applicable) of the purchaser of each draw ticket must be recorded on the counterfoil of that ticket.
- 4. The draw must be conducted in public by the organiser and any person in the employment of the organiser.
- 5. The draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
- 6. The draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 7. The organiser must, before the start of the draw, undertake to ensure that a notification of the win is sent to each winner of the draw by ordinary post.
- 8. The organiser must, before the start of the draw, undertake to ensure that the results of the draw are published in one major daily newspaper in Singapore within 7 days after the determination of all the winners.
- 9. The organiser must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 25 February 2019.
