Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 7) Order 2019 and comes into operation on 3 September 2019.

Declaration of precincts for Home Improvement Programme

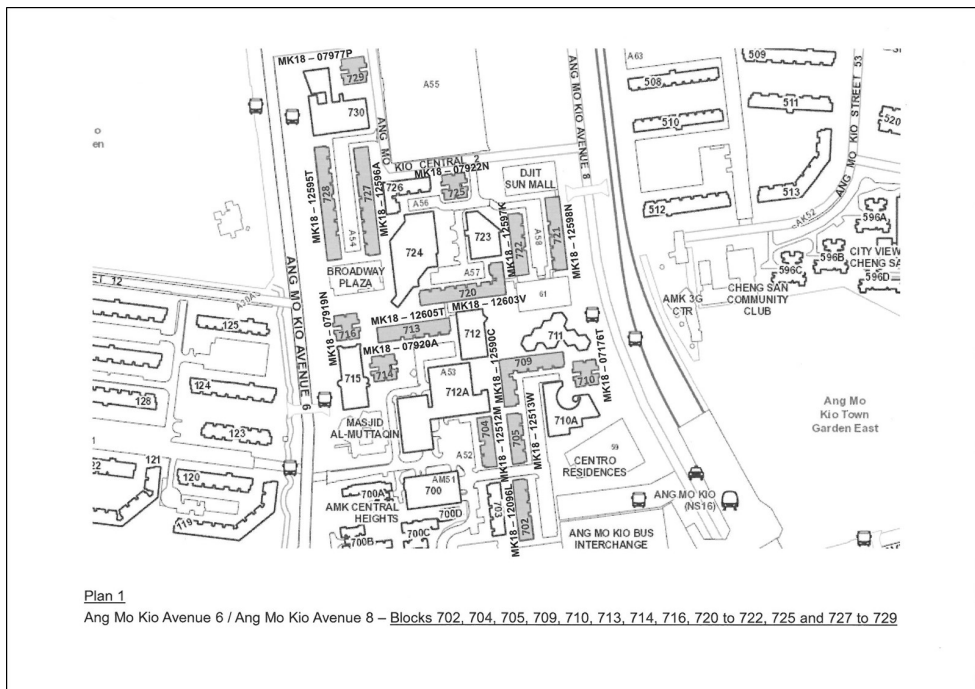
2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

ANG MO KIO AVENUE 6/ANG MO KIO AVENUE 8

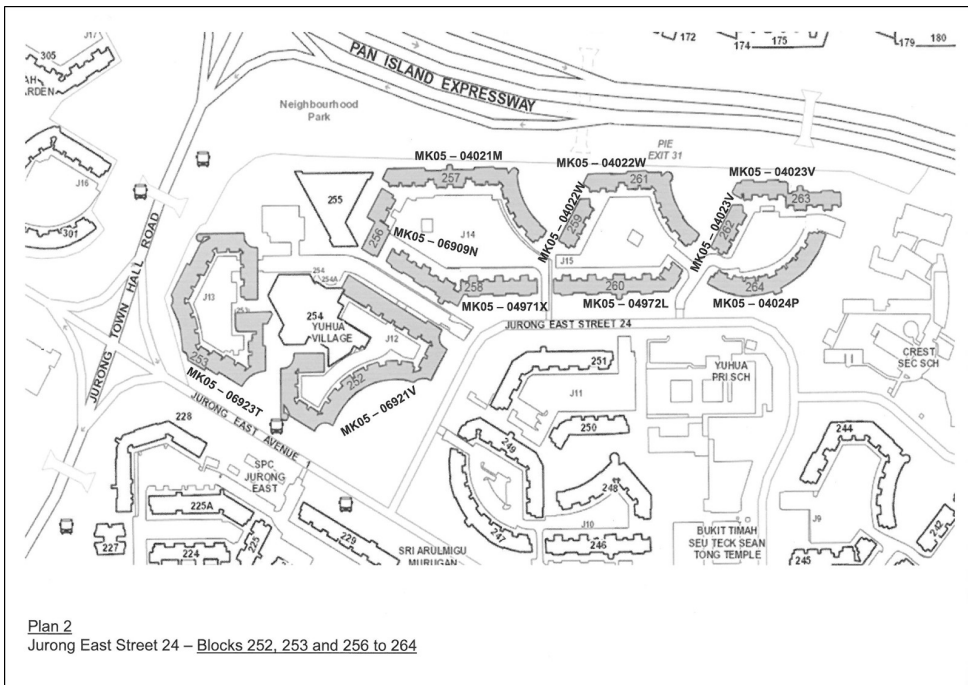

JURONG EAST STREET 24

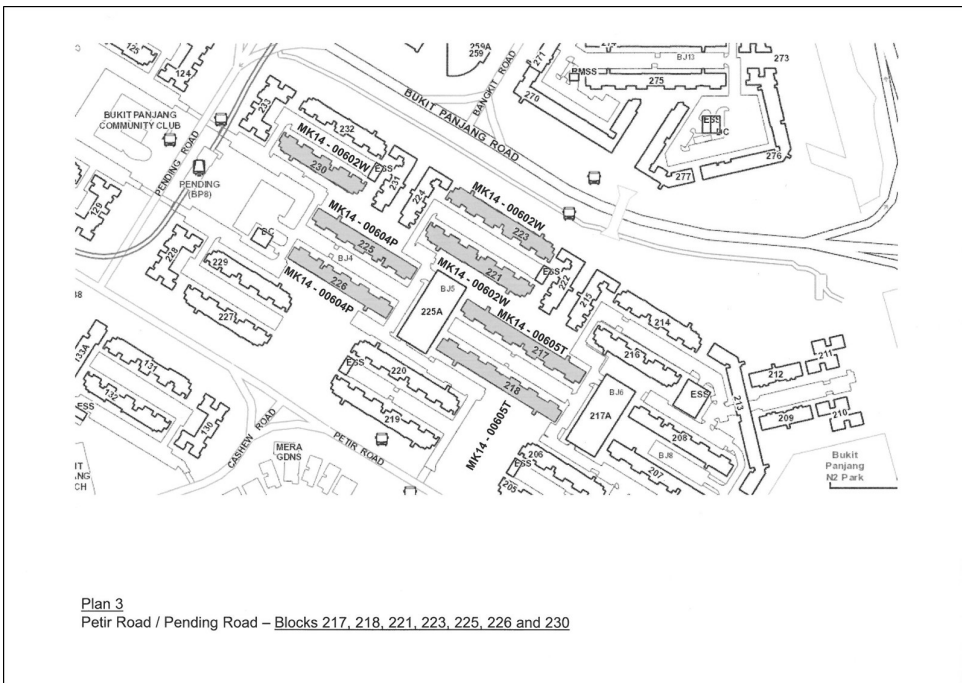

PETIR ROAD/PENDING ROAD

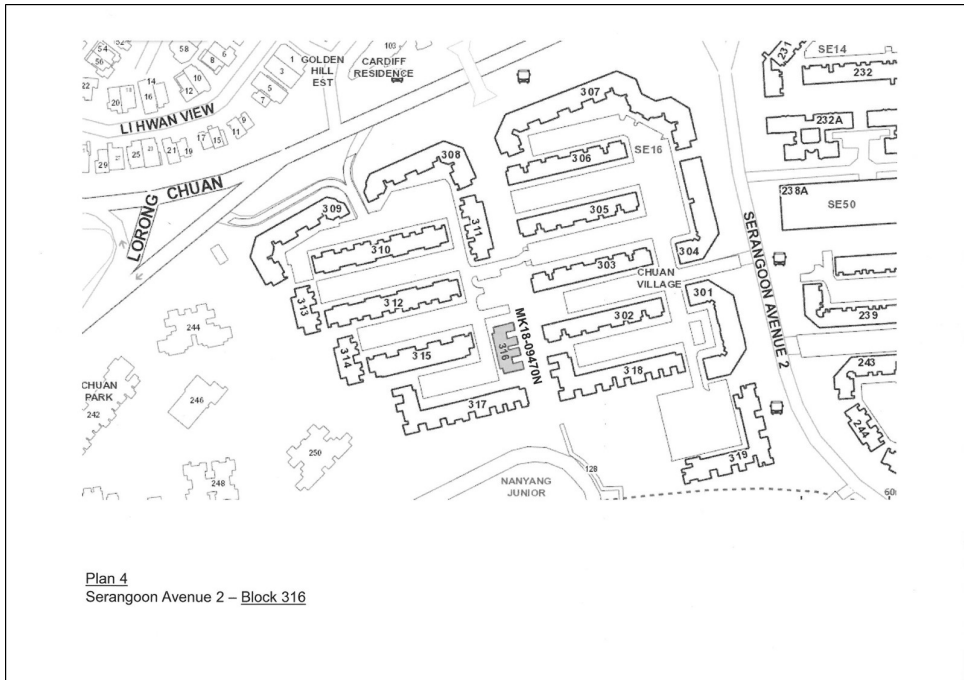

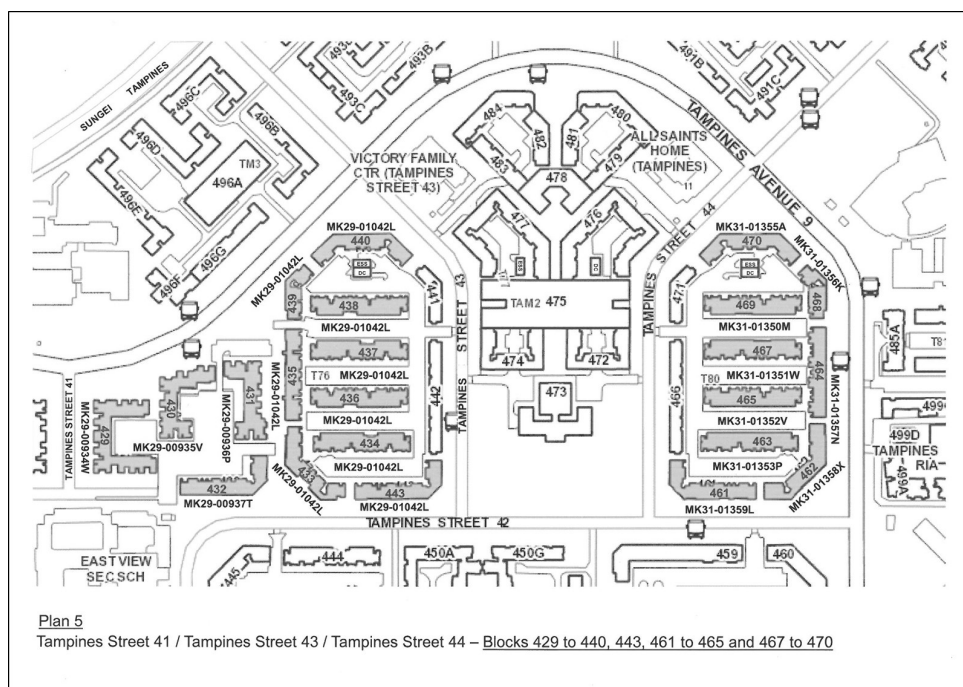
SERANGOON AVENUE 2

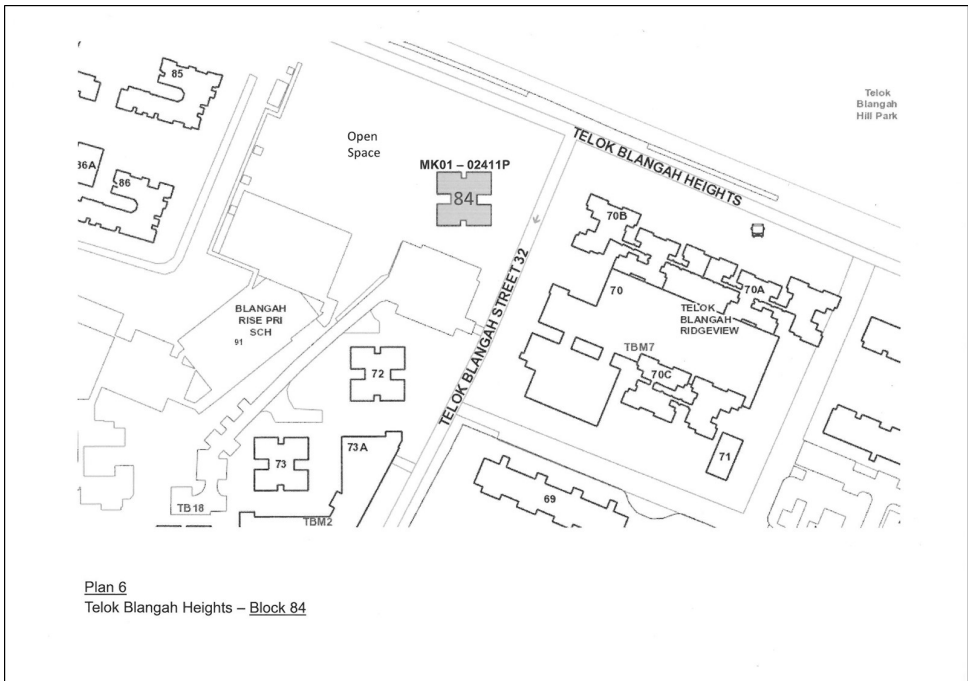

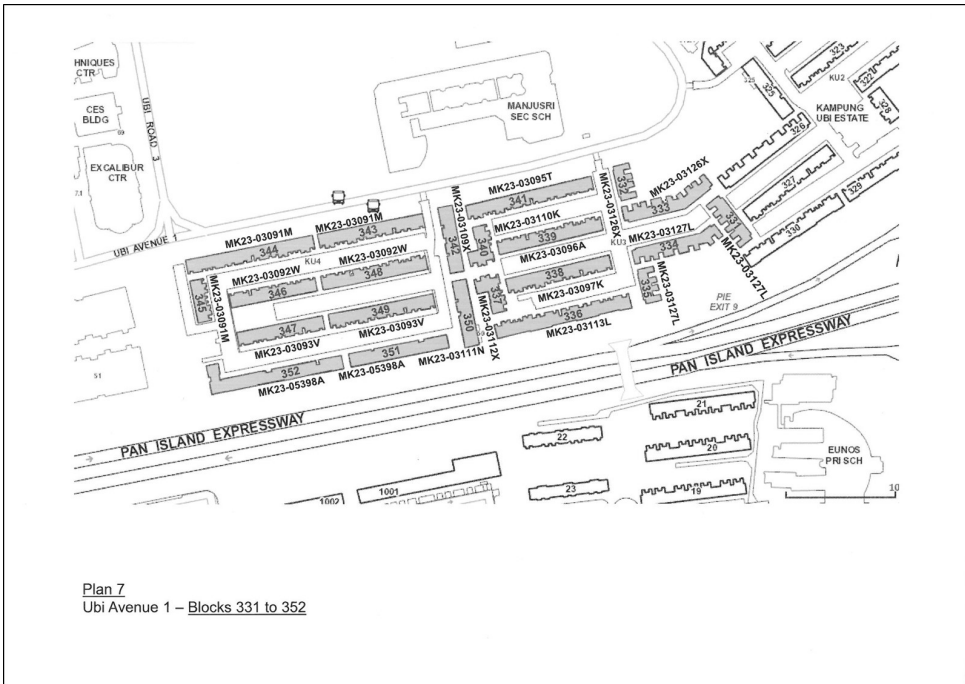
TELOK BLANGAH HEIGHTS

UBI AVENUE 1

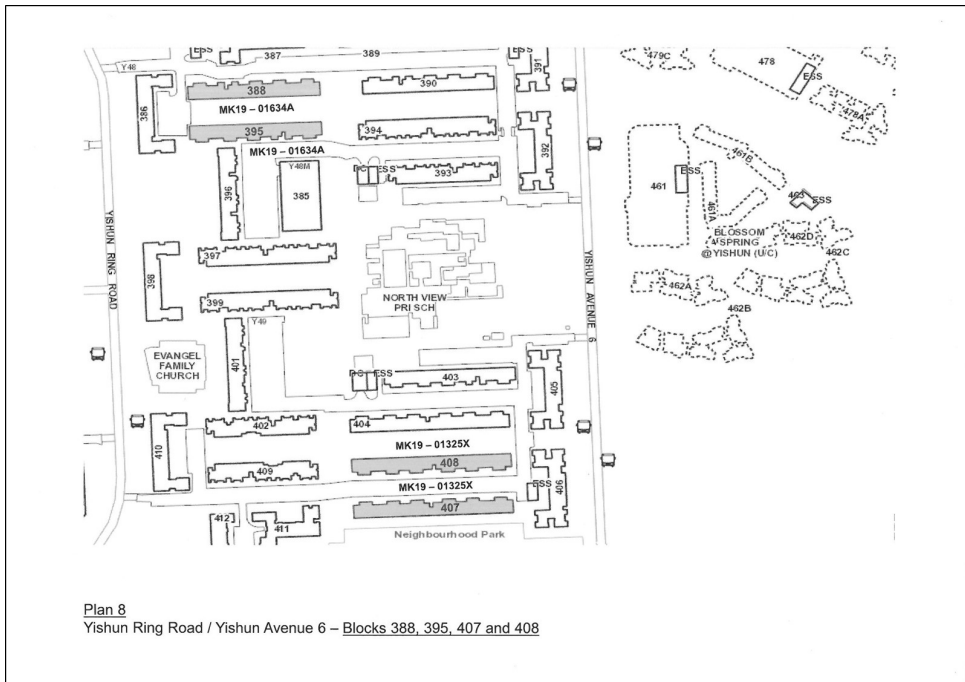
