SINGAPORE TOURISM (CESS COLLECTION) ACT (CHAPTER 305C)

SINGAPORE TOURISM (TOURIST HOTELS, TOURIST FOOD ESTABLISHMENTS AND TOURIST PUBLIC HOUSES) (AMENDMENT NO. 2) NOTIFICATION 2013

In exercise of the powers conferred by the definitions of "tourist hotel", "tourist food establishment" and "tourist public house" in section 2 of the Singapore Tourism (Cess Collection) Act, Mr S Iswaran, Second Minister for Trade and Industry, charged with the responsibility for the portfolio of the Minister for Trade and Industry relating to tourism, hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Singapore Tourism (Tourist Hotels, Tourist Food Establishments and Tourist Public Houses) (Amendment No. 2) Notification 2013 and shall come into operation on 6th September 2013.
