CONSTITUTION OF THE REPUBLIC OF SINGAPORE (RESPONSIBILITY OF THE MINISTER FOR SOCIAL AND FAMILY DEVELOPMENT) NOTIFICATION 2013

Responsibility of Minister for Social and Family Development

It is hereby notified for general information that, pursuant to Article 30(1) of the Constitution of the Republic of Singapore, the Prime Minister has directed that Mr Chan Chun Sing shall, with effect from 1st September 2013, be charged with the responsibility for the departments and subjects set out in the Schedule and that he shall be designated as the Minister for Social and Family Development.
