(a) payable on every anniversary of date of issue of warrant of arrest, falling before 1 July 2014	\$14
(b) payable on every anniversary of date of issue of warrant of arrest, falling on or after 1 July 2014	\$16

(ii) payable on 2 January 2015 and every subsequent anniversary of that date	\$16
