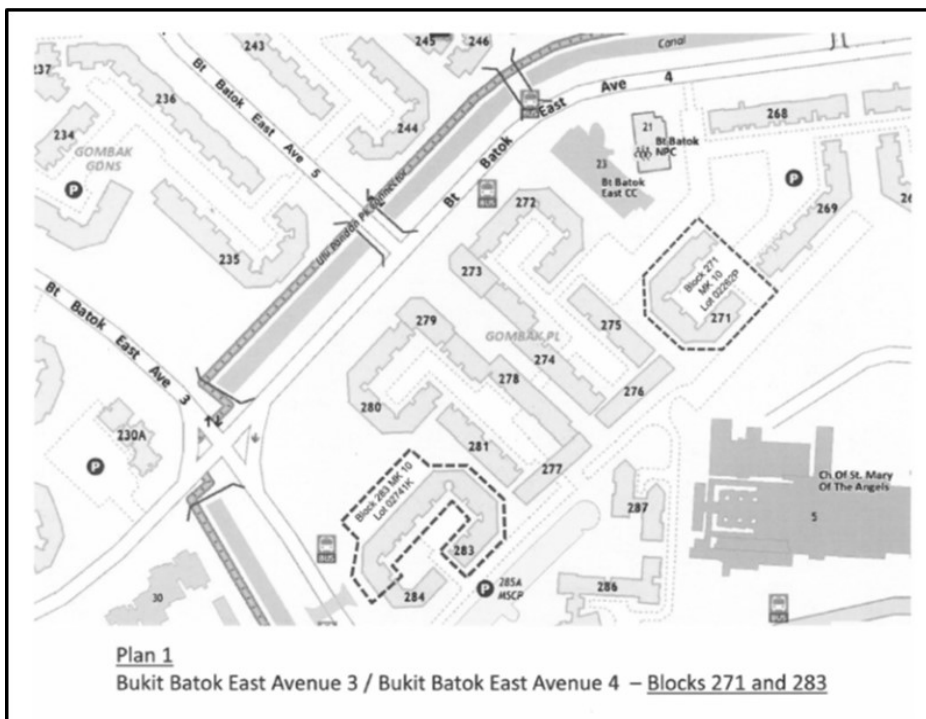

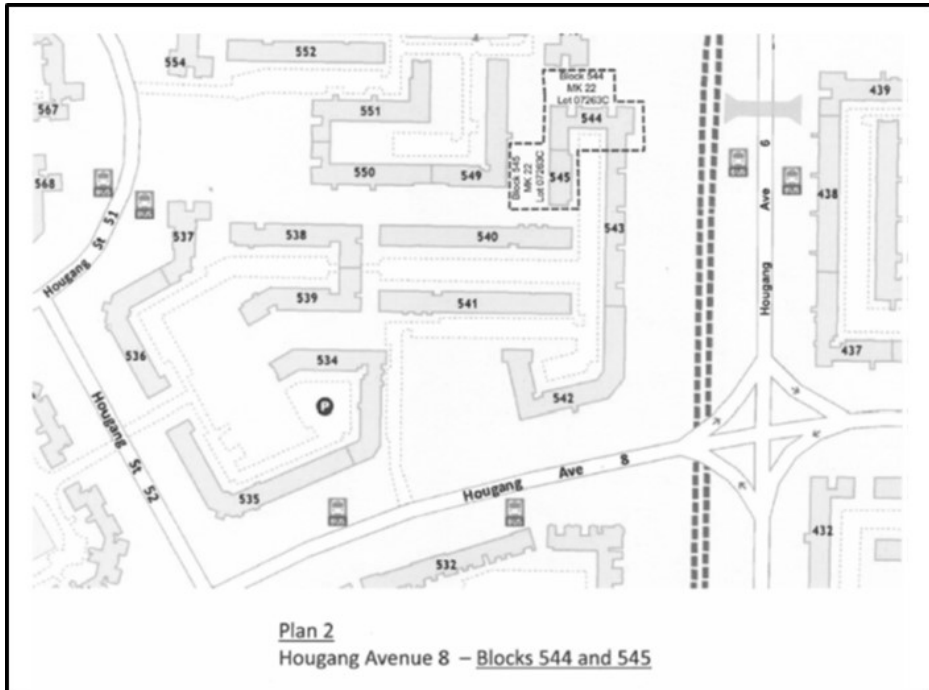
BUKIT BATOK EAST AVENUE 3/BUKIT BATOK EAST AVENUE 4

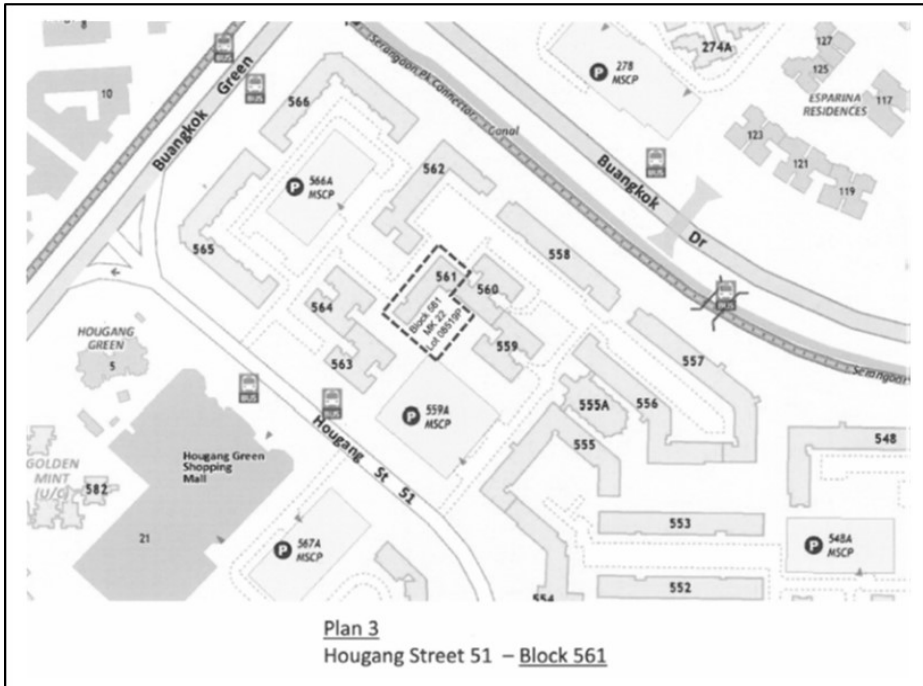
HOUGANG AVENUE 8

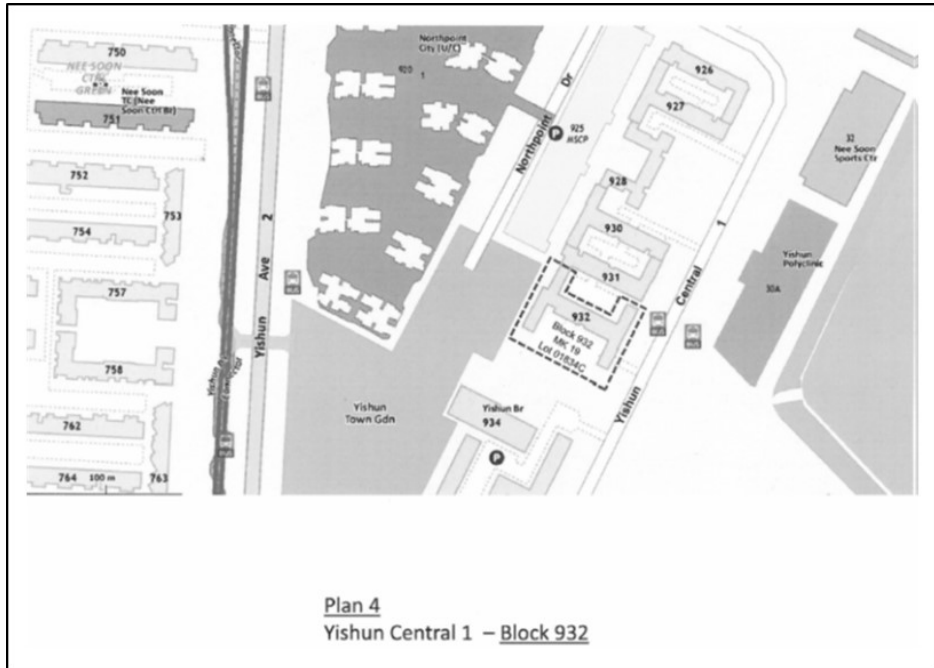
PLAN 3
