In exercise of the powers conferred by section 10 of the Street Works Act, the Land Transport Authority of Singapore hereby makes the following Notification:

**Citation**

1. This Notification may be cited as the Street Works (Creation of Rights) (No. 2) Notification 2013.

**Powers of Authority**

2. The Authority or any person authorised by the Authority may, at any reasonable time and for the purposes of and incidental to the maintenance of a road structure or road related facility, enter upon the lands described in the First Schedule and exercise such rights as are described in the Second Schedule on those lands.

**Inspection of plans**

3. Copies of the plans of the lands described in the First Schedule shall be available for inspection by the public free of charge at the

office of the Land Transport Authority of Singapore at 1 Hampshire Road, Singapore 219428 —

- (a) between 9 a.m. and 5 p.m. of any day from Monday to Friday (except public holidays); but
- (b) if any such day is the eve of the New Year, Lunar New Year or Christmas, between 9 a.m. and 12 noon.

## SECOND SCHEDULE

Paragraph 2

1. The right of uninterrupted passage with or without vehicles for the purpose of access and egress to and from any road structure or road related facility constructed on the lands described in the First Schedule or any other land adjoining thereto.
2. The right at all times to have any road structure or road related facility constructed by the Authority on the lands described in the First Schedule to be supported, upheld and maintained by the soil and subsoil of such lands.
