### COMMON GAMING HOUSES (EXEMPTION) (NO. 57) NOTIFICATION 2015

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

#### **Citation**

**1.** This Notification may be cited as the Common Gaming Houses (Exemption) (No. 57) Notification 2015.

#### **Definitions**

**2.** In this Notification —

“draw” means any one of the 5 sessions of draws conducted hourly from 11 a.m. to 3 p.m. on 24 October 2015 as part of the promotion;

“organiser” means the committee led by the Dean of the Diplomatic and Consular Corps of the Republic of Singapore, responsible for organising the promotion;

“promotion” means the SG50 Diplomatic Charity Bazaar to be held from 10 October 2015 to 24 October 2015 (both dates inclusive).

## **Exemption**

- 3.—(1) The Minister exempts the organiser from the provisions of the Act in respect of the promotion, and each draw to be held at the Tower Ballroom of Shangri-La Hotel.
- (2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

## **THE SCHEDULE**

Paragraph 3

### **CONDITIONS**

1. The price of a draw ticket, the name and address of the organiser, and the details of the prizes to be distributed, must be clearly stated on each draw ticket.
2. A draw ticket must only be issued by way of sale and upon receipt of its price in full.
3. The name, identity card number (if available), contact number and email address (if available) of the purchaser of each draw ticket must be recorded on the counterfoil of that ticket.
4. A draw may only be conducted by the organiser.
5. Each draw must be conducted in public.
6. A draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act.
7. A draw must not involve the use of any instrument or appliance for gaming declared by the Minister under section 2(4) of the Act.
8. The prizes for each draw must be distributed on 24 October 2015 at the Tower Ballroom of Shangri-La Hotel.
9. The organiser must, before the start of the promotion, undertake to ensure that an audited statement of the accounts and result of every draw is sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 25 January 2016.
