In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 6) Order 2011 and shall come into operation on 1st November 2011.

Declaration of precincts for Home Improvement Programme

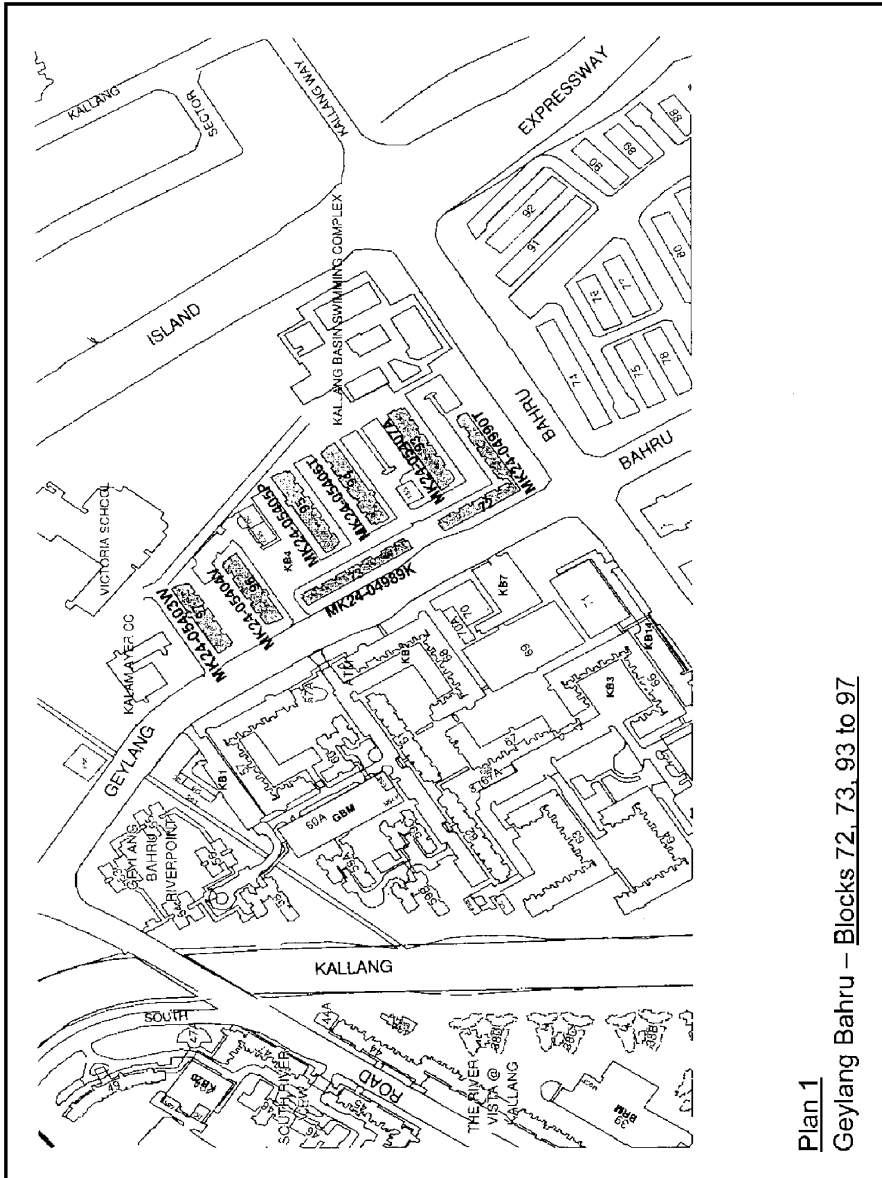
2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board at Geylang Bahru comprised in Lot numbers 04990T, 04989K, 05407A, 05406T, 05405P, 05404V and 05403W in Mukim 24 and on which Apartment Blocks 72, 73, 93, 94, 95, 96 and 97 are erected, and which is more particularly shaded in Plan 1.

GEYLANG BAHRU



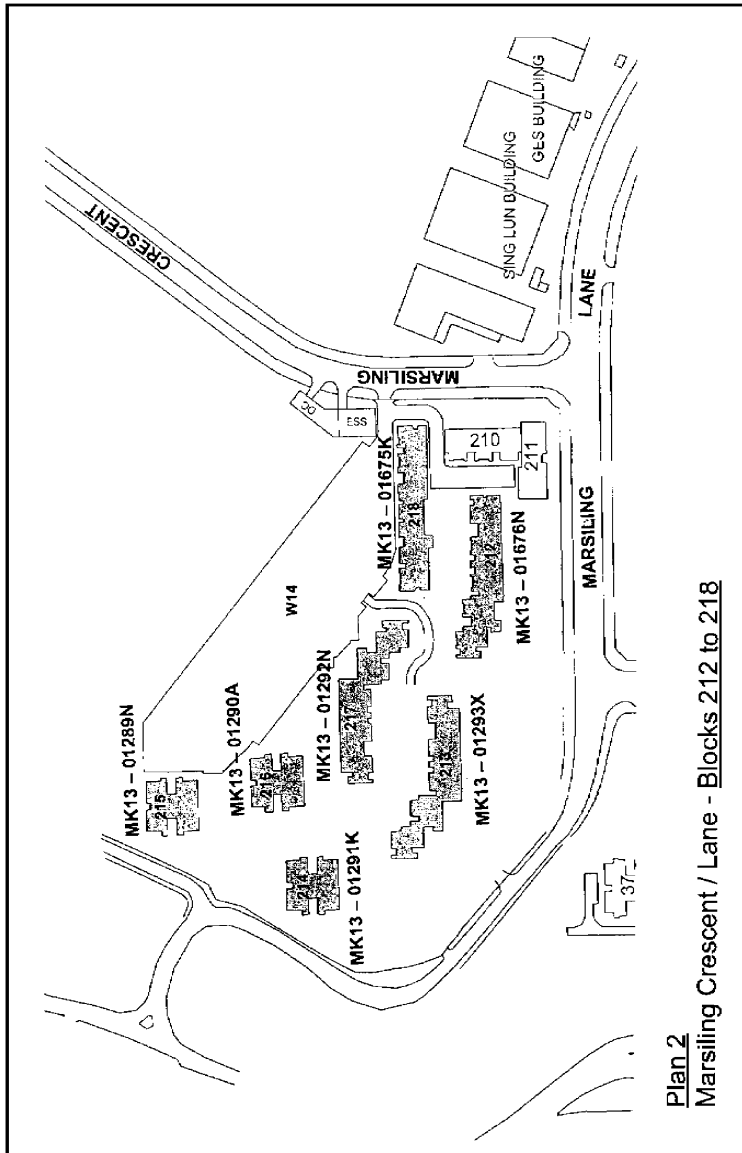

All that part of the housing estate of the Board at Marsiling Crescent/Lane comprised in Lot numbers 01676N, 01293X, 01291K, 01289N, 01290A, 01292N and 01675K in Mukim 13 and on which Apartment Blocks 212, 213, 214, 215, 216, 217 and 218 are erected, and which is more particularly shaded in Plan 2.

PLAN 2

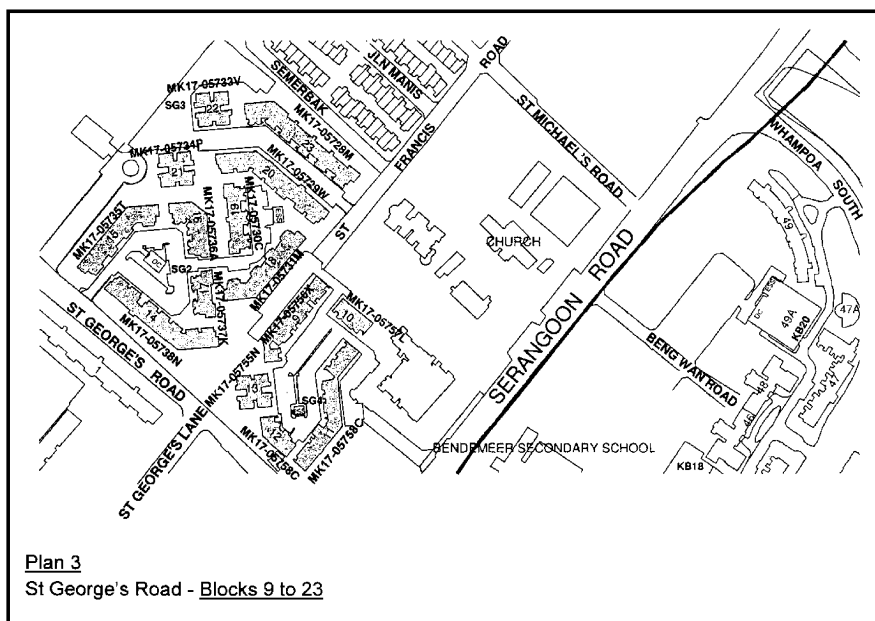
MARSILING CRESCENT/LANE
