### EMPLOYMENT OF FOREIGN MANPOWER ACT 1990

# EMPLOYMENT OF FOREIGN MANPOWER (WORK PASSES) (AMENDMENT) REGULATIONS 2023

In exercise of the powers conferred by section 29 of the Employment of Foreign Manpower Act 1990, the Minister for Manpower makes the following Regulations:

### Citation and commencement

**1.**—(1) These Regulations are the Employment of Foreign Manpower (Work Passes) (Amendment) Regulations 2023 and, except for regulation 2, come into operation on 13 February 2023.

(2) Regulation 2 is deemed to have come into operation on 10 October 2022.

#### Amendment of regulation 1A

**2.** In the Employment of Foreign Manpower (Work Passes) Regulations 2012 (G.N. No. S 569/2012) (called in these Regulations the principal Regulations), in regulation 1A, in the definitions of "cleared status (general)" and "cleared status (special)", delete "Access Restrictions and".

#### **Amendment of Fourth Schedule**
