PROTECTED PLACES (NO. 5) ORDER 2015

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 5(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs makes the following Order:

Citation and commencement

1. This Order may be cited as the Protected Places (No. 5) Order 2015 and comes into operation on 26 October 2015.

Premises declared to be protected place

2.—(1) The premises described in the second column of the Schedule is declared to be a protected place for the purposes of the Act.

(2) No person may enter or remain in those premises unless the person —

- (a) is in possession of a pass-card or permit issued by the authority specified in the first column of the Schedule; or
- (b) has received the permission of an authorised officer on duty at those premises to enter those premises.

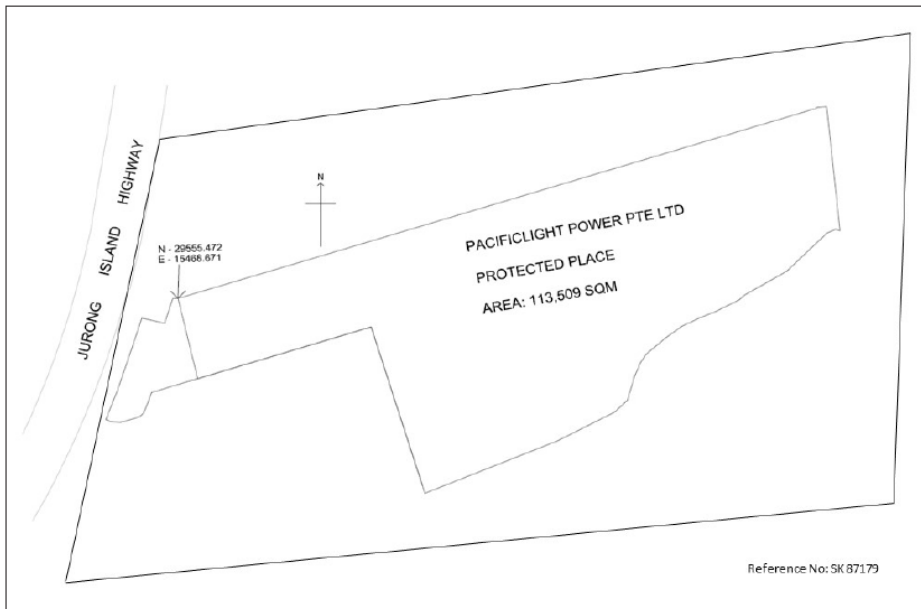
