COMMON GAMING HOUSES ACT (CHAPTER 49)

COMMON GAMING HOUSES (THE JAPANESE ASSOCIATION — EXEMPTION) NOTIFICATION 2019

ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

Citation

1. This Notification is the Common Gaming Houses (The Japanese Association — Exemption) Notification 2019.

Exemption

- 2.—(1) The Minister exempts the society registered under the Societies Act (Cap. 311) known as The Japanese Association, Singapore (UEN S62SS0062K) (called in this Notification the organiser) from the provisions of the Act in respect of
 - (a) "The Japanese Association Open House cum Charity Bazaar and Charity Draw 2019" promotion to be held from 12 September 2019 to 23 November 2019 (both dates inclusive); and
 - (b) the draw to be held as part of the promotion at 1.15 p.m. on 23 November 2019 at 120 Adam Road, Singapore 289899.

(2) The exemption is subject to compliance by the organiser with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2(2)

CONDITIONS

- 1. The price of the draw ticket, the name of the organiser, and the details of the prizes to be distributed, must be clearly stated on each draw ticket.
- 2. The draw ticket must only be issued by way of sale and upon receipt of its price in full.
- 3. The name, membership number (if available), contact number and address (if available) of the purchaser of each draw ticket must be recorded on the counterfoil of that ticket.
- 4. The draw must be conducted in public by the organiser and persons in the employment of the organiser.
- 5. The draw must not involve the use of any game, method, device, scheme or competition declared by the Minister under section 2(3) of the Act to be a lottery or a game of chance or of mixed chance and skill.
- 6. The draw must not involve the use of any article declared by the Minister under section 2(4) of the Act to be an instrument or appliance for gaming.
- 7. The organiser must, before the start of the promotion, undertake to ensure that a notification of the win is sent to each winner of the draw by ordinary post.
- 8. The organiser must, before the start of the promotion, undertake to ensure that the results of the draw are published in one major daily newspaper in Singapore within 7 days after the determination of all the winners.
- 9. The organiser must, before the start of the promotion, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 24 February 2020.
